Sir/Madam,

I, Rakesh Saha, S/o Sri. Ranjit Saha resident of A.P.C Sarani, Deshbandhu Para, Siliguri Town, P.O & P.S: Siliguri, Dist: Darjeeling, West Bengal, Pin Code: 734001 would like to lodge a complaint against Smt. Chumki Saha, D/o Sri. Uttam Saha, her mother i.e Smt. Rina Saha, her father Sri. Uttam Saha and her brother i.e Sri. Shubhojit Saha all residents of Dabgram, Bakrabhita, Sahudangi Hat, Dabgram, Dist: Jalpaiguri, West Bengal, Pin Code: 735135

I and Chumki Saha were in a love relationship since over 2 years now. Both our families know about our relationship and said chumki saha assured me and promised me that we will marry by the end of 2023. On the basis of this assurance we kept meeting each other and had grown a level of trust with each other. Chumki Saha on various occasions has asked me to buy her gold ornaments and expensive things like phones, etc. On last February 2023 she demanded an apple phone and out of love and affection for my girlfriend I have gifted an Iphone 13 to her. But her demand for things kept increasing and her promise to marry me kept shifting from one date to another.

In and around 19th September 2023, I got a lottery reward of Rs. 45,000/- and when I told her the same, she started demanding it from me again promising me that she will return it after 2 months. Being in love with her I gave her the entire Rs. 45,000/- on her promise to repay the same. On various occasions I have asked her about our marriage but she kept giving one excuse or the other but at the same time kept meeting me, taking things from me. After pursuing her many times to return my money she paid me only Rs. 10,000/- out of the total money.

Lastly, on 04/02/2024 when I again asked her about our marriage she again started giving one excuse or the other and told me to wait another 1 year. I realized that I was being catfished and she had no intention to marry me but to only use me, extort money from me, I asked her to give my things back especially the iphone 13 and the Rs. 35,000/- that I had given her amongst many other things. She started abusing me and then also included her family. They then called me at their house to come and get all the things and money.

At around 12 in the night, I along with my staff i.e Sri. Jayanta Barui went outside her house at Bakrabhita, Sahudangi hat, Dabgram, Dist: Jalpaiguri, under P.S NJP, West Bengal, Pin Code 734001 and she and her family i.e her mother i.e Smt. Rina Saha, her father Sri. Uttam Saha and her brother i.e Sri. Shubhojit Saha on seeing me rushed towards us and started beating us with fist and blows. I and my said staff resisted with our bare hands as we could but they didn't stop. Chumki Saha picked up an iron rod and hit us also damaged my bike with it, she snatched my gold chain that I was wearing and her brother i.e Shubhojit Saha had a bamboo sort of thing with which he hit my staff on his knee and pushed him, throwing him on the ground. I was also severely beaten up and I have suffered several injury throughout my body. Her mother abused us in the filthiest of manner and on the interference of the surrounding people we were saved and anyhow I brought my staff to the Siliguri District Hospital emergency for treatment of all the injury he faced from the physical assault.

When we were rushing out from there they didn't hesitate to threaten us that they would kill us if they ever saw us. I fear for our safety and health. Please take necessary action against them.
