Subject: Complaint against Goutam Sarkar and Bina Sarkar.

Respected Sir/Madam,

I, Smt. Pinki Sarkar Nandi, resident of Purbadhantala, Dabgram (P), P.S. NJP, Dist. Jalpaiguri, Pin - 734015, wish to bring to your attention the distressing situation arising from my marriage to Mr. Goutam Sarkar, a resident of Purbadhantala, VTC: Dabgram (P), PO: Fulbari Hat, Sub District: Rajganj, Dist: Jalpaiguri, Pin 734015. The marriage was solemnized on 14/07/2004. After the marriage I used to live with my husband in his home along with my mother in law Smt Bina Sarkar.

Since the inception of our marriage, both my husband, Mr. Goutam Sarkar, and his mother, Bina Sarkar, have subjected relentless physical and mental torture upon me. They have consistently inflicted physical violence upon me and resorted to using filthy language, causing immense physical pain and mental trauma. Despite enduring such mistreatment and ill behavior, I had hoped for a positive change over time. However, their behavior only escalated, affecting not just me but also our children, namely Rajesh Sarkar aged about 18 years and Disha Sarkar aged about 10 years.

My husband neglected his responsibilities towards me and our children, My Husband and in-laws did not provide us with enough food to eat and never ensured we had basic necessities, including medical care. Despite my efforts to provide for our family by working and managing all household duties single-handedly, he showed no regard for our well-being. Because he often drank excessively and came home intoxicated frequently,

he would also ask for money. He would spend that money on his own pleasures and enjoyment. If I refused to give him money, he would mercifully beat me used filthy language upon me and my children. My husband and my in-laws used to ask me to bring money from my parents and when I could not they often used to beat me mercilessly.

Lastly, on 27/01/2024, he returned home intoxicated very late at night and subjected me and our children to further abuse. He inflicted physical torture upon me, abused me with very filthy language, and threatened me with my life. Unable to endure the situation any longer, I sought refuge with my relatives in Dagapur Bandrijote, PS-Pradhan Nagar and living under constant threat and fear I have not taken any steps and now I have come to complain against him.

I urge you to take decisive action against Mr. Goutam Sarkar and Smt Bina Sarkar to ensure justice and prevent further harm.
