Dear Sir,

I am writing to bring to your attention the unfortunate incident has been detected by the undersigned along LT Mobile Van attached to Fulbarihat CCC on 07.02.2024, isolator base and electrical materials has been stolen from different locations under the jurisdiction of Fulbarihat CCC namely; Fulbari Canel Road near Sonar Tari Restaurant, DTR opposite Maharaja Hospital, Balaram Milk Factory, Jatiakali from Narayana School to riverend (All DTR). I wish to formally inform the Njp Police Station about these incidents.

The first incident occurred at 1. Fulbari Canel Road near Sonartori Restaurant, 2. DTR opposite Maharaja Hospital & 3. Balaram Milk Factory, where 12 nos Cut Out has been stolen at unknown dates. The second incident occurred at all DTR Jatiakali from Narayana School to river end where 10 nos isolator has been stolen at unknown dates. The estimated value of the stolen items is Rs.36,400. As the rightful owner of these stolen items is WBSEDCL, I request your assistance in investigating the matter and taking appropriate action to recover the stolen property and bring the culprits to justice. I am also willing to provide any additional information or evidence that may aid in the investigation. I kindly request that the Njp Police Station also take swift action in this matter and keep me informed about the progress of the investigation. Take necessary steps to prevent such incidents in the future to ensure the safety and security.
