It is hereby inform you that I have one Shop at Nehru Road, Opposite to Amalgamated Transport, in ward no. 8 of SMC, Siliguri, Dt. Darjeeling. Sir I am dealing in Agarbatti and yesterday i.e. 05/02/2024 when my staff Sri Tapan Roy went for his lunch to his home at about 1.30 p.m. and after coming from having his lunch from his home at about 4 p.m. and noticed that the main door of shop is open and our Cash box inside the shop also broken. Then he call to Sri Sitaram Agarwal my manager and inform the incident. Then Sri Sitaram noticed that the amount about Rs. 30,000/- (Rupees thirty thousand) which is kept in the cash box is not in the cash box.

Then we came to know that some one stolen the amount from the Cash Box by breaking the Cash Box.

We noticed that one person who came to buy Agarbatti near about 1.40 p.m. and asked nearer our shop room that where is the staff of my shop room and informed that he has to buy Agarbatti. And he informed by the nearer shop owner that he is going to have his lunch. Then he sit in stair case out side the Shop Room. But when my staff Sri Tapan Roy after his lunch he did not seen any person out side the shop.

We suspect that the person who came to buy Agarbatti he stolen the money.
