SUBJECT: - FIRST INFORMATION REPORT

Respected,

Sir/Madam,

I, Smt. Dipannita Das, W/O Sourav Basu, D/O Dipankar Das, resident of Jeevan Sathi Apartment, 4<sup>th</sup> Floor, Sreemaa Sarani, Babupara, P.O-Siliguri Town, P.S-Siliguri, Dist Darjeeling, would like to inform you as follows; -

1. That my marriage was solemnised in the year 2013, on 28<sup>th</sup> November, with one Sourav Basu S/o Swaraj Kr. Basu Resident of 74, Satyen Bose Road, Deshbandhupara, P.O-Siliguri Town, the marriage party was held at Babupara Sakti Sopan Club.
2. That after my marriage reception I and my husband, Sourav Basu had shifted to Kolkata to stay along with my brother-in-law in a rented apartment. Both my in laws (Swaraj Kr. Basu and Sagarika Basu) used to visit in our residence regularly, I being their daughter-in-law always nurtures my in laws whenever they stayed with us but they never satisfied with me and my companions even though I had listened to them whatever they had instructed to me. But their interference towards me and my husband martial issue had created differences between us.
3. That my husband Sourav Basu always blames me in every circumstance and didn't bother to listen my words. As a result my simple faults would become a big issue in the house and from then on everyone used to pinch me with abusive words, threat me and since the day of marriage I was facing this type of mental torture each and every day. I being a legally wedded wife my husband did not bother to pay me a single furthing to run my livelihood, even my in laws had never allowed him to do so.
4. That Being frustrated by my husband and my in laws acts, I had applied for a service/ job and when I was selected I had circulated the news with my in-laws but it was my misfortune that my in-laws had pressurized me not to join any job saying that they are capable enough to look after me but after several requests from my end my in laws permitted me to join the said job but also put condition that I have to borne my own livelihood.

5. That the Mental torture was in such a status that simple watermelon cutting ways was also commented on me stating that your parents didn't teach you how to serve and my mother-in-law (Sagarika Basu) simply put the watermelon into the dustbin and threw the plate towards me. My in-laws (Swaraj Kr. Basu, Sagarika Basu and Siddhartha Basu) on each and every occasion interfere in family affairs, commented abusive words against me and sometimes they used to slap me on my cheek, hand and used to roll my fingers.
6. That whenever I tried to inform or talk with nearby people (ladies) regarding mental torture towards me, my in-laws used to keep eyes on me and did not even let me talk with them. Frequently my in-laws threat me stating not to tell anyone regarding household matters or to outsiders as my in-laws were very much concerned regarding their false status. Most of the time when my in-laws along with my husband used to go for outing all four of them humiliate me by passing remark regarding my dress code, my lifestyle. I was not allowed to wear according to my choice, I was forced to lead a life as per their willing.
7. That On 14<sup>th</sup> February 2015, after valentine day party when I and my husband entered our apartment, my in-laws started abusing me with abusive words. On that even day, all of them along with my husband tortured me regarding the simple issues which continued till 3 am, They physically tortured me by beating, with fist and blows and pushed me on floor. My father-in-law (Swaraj Kr. Basu) dragged my leg from bed to floor ultimately, I was fainted. Whole night I was not allowed to have food. My husband had witnesses everything and enjoyed. In the morning around 6.00 am when I heard that our neighbour was asking regarding last night chaos as they heard hue and cry from our apartment but my in-laws on the pretext had ended the topic.
8. That as usually after facing daily basis mental and physical torture I used to remain in myself and in that juncture my husband with his ill motive and high level contacts has taken me to a psychologist but later on I came to know that I had visited to a psychiatric doctor and I was forced to take those medicines and later on when my health issues got deteriorated I never used to have those medicines.
9. In the year 2017, my husband and I started living separately in another rented apartment for our betterment. But every time my in-laws used to poke my husband against me on that occasion without my consent my husband used to do sexual assault forcefully. Under this verbal, emotional and physical torture, on and off we had to come to Siliguri as my in-laws have home here. Whenever we came, my in-laws used to threat me by saying "Kolkatai ja kichu hoyeche kauke bolbena", accordingly, I had followed it from 2013-2022 till my final breakdown.

10. That even they threat not to share my pregnancy news to my parents. After my pregnancy, I didn't return back to Kolkata as I was staying in Siliguri in in-laws' home but after the birth of my baby boy's birth. In the year 2020 they started torturing me and intentionally they discontinue the maid and force me to do all the household chores. As I was Caesarean mother, they treated me as house maid. Being a breast feeding mother, my in-laws used to give less food to me. They close all the windows of home and then verbally, emotionally abuse me so my voices do not go out. My in-laws did not allow me mix with other family members, force me not to take out the baby outside and if I did, they pounced and abused me. Seeing that my little boy used to cry because I was also crying and they detach me from my son, taking his clothes and keeping in their wardrobes and other necessary items.
11. That on 5<sup>th</sup> January, 2022, at 1.00 am my in-laws barged into my room as my son was crying and my in laws abused me with slang, abusive words and question my motherhood. My brother-in-law (Siddhartha Basu), father-in-law (Swaraj Kr. Basu) pulled, abused me and my husband (Sourav Basu) was standing in front of me watching everything but did not do anything for us. Then on 6<sup>th</sup> January, 2022, finally only for my son's ultimate welfare and wellbeing I left my in-law's house. I am staying with my parents' place with my son.
12. That on April, 2022, my son got admission in DPS School while my son was 2.7 years at that time. While going to school, and returning from school my husband started verbal abuse. Initially it was indirect then as time passes, he made direct derogatory abusive words as a result my son had catches certain abusive words. Occasionally in the evening, he used to come to my parents' home and commented on his lifestyle, commented on my parents. My son that time had spoken up abusive phrases and words in front of everyone so forcefully I had decided to discontinue his schooling from DPS.
13. That from 6<sup>th</sup> January, 2022, to till date entire financial support from my husband was stopped for me and my son. On January, 2023, I had admitted my son in school which is near to my parents' home. On that very occasion, my husband grabbed me on road and threat me "where you and your son will go, you have to come to us". Then, for my son's safety and security after this incident I placed a G.D on 22.1.2023 being no. 1313 and one copy I gave to my son's school.
14. That on 21<sup>st</sup> October, 2023, at 12.30 P.M my husband called me for a talk but publicly my husband grabbed my chest, use abusive slangs in loud voice in front of my child and continuously on road use slangs languages towards me and my father, and he also

came along with group of people to attack us physically and lastly on 7<sup>th</sup> February, 2024, at around 2.30 P.M I received a phone call from a computerised number which I could not save and my husband threatened me saying that "ami toke ar tor santan ke mere nejeo morbo", and as a result I am frightened with my son and lastly I had to make complaint before your authority to take necessary steps.

So, I request/ beg before your authority to look into the matter and punish the above named accused persons for spoiling my life along with my baby for ends of justice.
