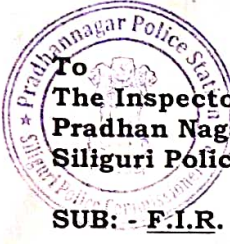

Sir,

In producing herewith one arrested accused person named Yubaraj Subedi(23Y/M), S/O. Premnidi Subedi of Purba Karaibari, Milanmore, PS- Pradhannagar, Dist. Darjeeling under arrest along with following articles under proper seizure. The ground of arrest duly been communicated with him.

(i) One multy colour nylon bag containing 12 (Twelve) bottles of KINGFISHER IMPERIAL STRONG BEER, each bottle containing 650 ml, each bottle MRP-135 rupees (Total 7.8 litre). marked as exhibit A (Out of which one bottle has been taken as sample for examination marked as exhibit A1)

I, ASI Manoj Kr. Roy of Pradhan Police Station, SPC would like to lodge this written complaint against one accused person named Yubaraj Subedi(23Y/M), S/O. Premnidi Subedi of Purba Karaibari, Milanmore, PS- Pradhannagar, Dist. Darjeeling to the effect that today on 11.02.2024 at 18.50 hrs during mobile van duty received a source information that one person has been selling and procuring illegal liquor at his residence/Shop situated at Purba Karaibari, Milanmore under Pradhan Nagar Police Station without any valid license. Accordingly I informed the matter to the I/C PS and diarised the fact in General Diary vide Pradhan Nagar PS GDE No 636, dated 11.02.24 and as per his kind direction myself along with C/873 Shyamal Biswas and C/1411 Ashok Roy All of Pradhannagar PS had been to Purba Karaibari, Milanmore under Pradhan Nagar PS to verify the veracity of source information. After arrival at Purba Karaibari, Milanmore under Pradhan Nagar PS and as identified by the source I held raid at the residence cum shop of the above noted accused and managed to apprehended him. On being asked the apprehended person disclosed his name and identity as noted above. Further being searched the above noted articles have been recovered from his shop which were kept with a multy colour nylon bag. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is selling and possessing of liquor without any valid license since long for his illegal gain. Accordingly, I seized and labelled the above mentioned illegal illicit distilled liquor under proper seizure list in presence of witnesses and subsequently arrested the above mentioned person named Yubaraj Subedi(23Y/M), S/O. Premnidi Subedi of Purba Karaibari, Milanmore, PS- Pradhannagar, Dist. Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 19.35 hrs to 20.25 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Yubaraj Subedi(23Y/M), S/O. Premnidi Subedi of Purba Karaibari, Milanmore, PS- Pradhannagar; Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
