With due respect, I am producing herewith 01 (one) arrested accused person named Dilip Sarkar (47yrs) S/O Lt Niranjan Sarkar of Suryasen Colony, Blok "C", PS-New Jalpaiguri, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

(i) 12 (Twelve) bottles of Himalayan Gold Country Spirit 60 UP country Spirit (each bottle containing 600 ml.)

I, S.I Tanmoy Kundu presently attached with NJP PS, SPC under your kind control beg to state that on 10.02.2024 at 18.05 hrs, vide NJP PS GDE No.535, Dated- 10.02.2024, I received a secret source information that one person namely Dilip Sarkar (47yrs) S/O Lt Niranjan Sarkar of Suryasen Colony, Blok "C", PS-New Jalpaiguri, Dist.- Jalpaiguri is selling ID liquor illegally at Srinagar colony, under New Jalpaiguri, Dist.- Jalpaiguri in his shop. Accordingly, I diarized the fact in the General diary and as per order of O/C. NJP PS, myself along with C/V 824 Niru Yadav, C/V 297 Putul Roy, all of NJP PS, SPC left for Srinagar colony Bazar, , PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At 18.35 hrs we arrived at Srinagar colony Bazar and asper indication by the source, I apprehended the above noted person selling ID liquior at his Shop. On being asked he disclosed his name and address as Dilip Sarkar (47yrs) S/O Lt Niranjan Sarkar of Srinagar colony PS-New Jalpaiguri, Dist.- Jalpaiguri. During raid the persons who were buying liquor was able to fled away from the Shop. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop located at Srinagar colony, PS- NJP, Dist.- Jalpaiguri. On search in the shop the above noted I/D liquor recovered. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from the shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 18.45 hrs to 19.05 hrs on 10.02.2024.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused named Dilip Sarkar (47yrs) S/O Lt Niranjan Sarkar of Suryasen Colony, Blok "C", PS-New Jalpaiguri, Dist.- Jalpaiguri and arrange for its investigation.
