Sir,

In producing herewith one arrested accused person named Viswanath Kumar (24 yrs) S/O Ram Nihora Mahato of Dagapur, near Loknath Mandir, PS- Pradhan Nagar, Dist.- Darjeeling under arrest along with following articles under proper seizure list. The ground of arrest duly been communicated with him.

(i) 12 (twelve) bottles of Kingfisher Imperial Strong Beer containing 650 ml in each bottle i.e. total (12 x .650) = 7.8 ltrs which was kept in a paper made cartoon and marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A1".

I, SI Bandhan Roy of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person named Viswanath Kumar (24 yrs) S/O Ram Nihora Mahato of Dagapur, near Loknath Mandir, PS- Pradhan Nagar, Dist.- Darjeeling to the effect that today on 12.02.2024 at 20.55 hrs I received a specific source information that one Viswanath Kumar of Dagapur, near Loknath Mandir, PS- Pradhan Nagar, Dist.- Darjeeling is selling illicit liquor at his hotel styled as Shiv Hotel near Loknath Mandir, Dagapur under PS- Pradhan Nagar, Dist.- Darjeeling without any valid license. Accordingly, I informed the matter to the I/C PS and diarized the fact in General Diary vide Pradhan Nagar PS GDE No 878, dated 12.02.2024.

As per your kind order and direction, I along with C 1419 Ashish Ray, C 1169 Prasenjit Barman and C 1413 Sujit Sarkar left for Dagapur to verify the veracity of source information, On reaching there and as identified by the source I along with force conducted raid in a hotel styled as Shiv Hotel situated at near Loknath Mandir, Dagapur under PS- Pradhan Nagar, Dist.- Darjeeling and manage to apprehended the owner of the said hotel. On being asked he disclosed his identity as noted above. On being search the above noted seized articles were found in from the said hotel styled as "Shiv Hotel". On demand he failed to produce any valid license or papers for selling and storing of such illegal liquor. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license since long for his illegal gain. Then, I seized and labeled the above-mentioned illegal liquor under proper seizure list from his possession and subsequently, I arrested the above-mentioned detained person namely Viswanath Kumar (24 yrs) S/O Ram Nihora Mahato of Dagapur, near Loknath Mandir, PS- Pradhan Nagar, Dist.- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 21.40 hrs to 22.05 hrs at the spot in presence of available witnesses for violating the norms of Bengal Excise Act.

I, therefore pray before your good self that a specific case may kindly be initiated against accused namely Viswanath Kumar (24 yrs) S/O Ram Nihora Mahato of Dagapur, near Loknath Mandir, PS- Pradhan Nagar, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
