Sir,

This is to inform you that I Sri Soumyadeep Ganguly S/O Sri Sibnath Ganguly posted as Divisional Engineer (Tech) in Siliguri Town Division (W.B.S.E.D.C.L) would like to state that the aforementioned vehicle has collided with one 9-meter PCC pole structure supporting the live 11kV conductors of Housing feeder near Forresta Hotel, Eastern Bypass Road, Dist: Jalpaiguri around 3 pm today on 13.02.2024. Due to the collision, WBSEDCL had to incur a loss amounting to Rs. 30000 (appx). A large-scale power interruption also occurred due to the collision thereby creating a significant loss of face for WBSEDCL. The information was received from SM, Power House CCC who in turn received the message from a passerby. Thus, you are requested to take action accordingly.
