Sir,

In producing herewith following 02 (two) arrested accused persons namely i) Santosh Mahato (36) S/O Lt Nageshwar Mahato of Iskon Mandhir Bashjhar near Munibala School PS Bhaktinagar Dist Jalpaiguri. ii) Rony Ghosh (35) S/O Sailesh Ghosh of Haiderpara Bazar w/n 40 PO Haiderpara PS Bhaktinagar Dist Jalpaiguri along with the following articles under proper seizure. The ground of arrest duly been communicated with him.

- (i) One multi color bag pack style as "TM Sunny Style" containing 65 (sixty five) bottles of "WINCEREX" cough syrup codeine phosphate & Triprolidine Hydrochloride syrup each bottle containing 100 ml, having batch no WCRT1010, MFG date Dec 2023, EXP dated NOV 2025, which was carried by Santosh Mahato and marked as exhibit "A"
- (ii) One Black color gunny bag style as "Premium Rajnigandha" containing 40 (forty) packets of "WINSPASMO FORTE" each packet containing six (6) strips, each strips contains 24 capsules having batch no WPS23033, MFG date Dec 2023, Exp date Nov 2025 and it was carried by or kept at Scooty floor, which is marked as exhibit "B"(40*6=240*24=5760)
- (iii) One black color bag pack style as " American Tourister" containing ten (100 packets of Nitrozone-10 each packet containing 10 (ten) strips and each strips contains 10 (ten) tablet having batch no WNZZ1005, MFG dated Aug 2021, EXP dated July 2024 it was carried by Ronny Ghosh and marked as Exhibit "C" (10*10=100*10=1000)
- (iv) One Marron color scooty (TVS Jupiter) showing number WB 74 AW 1205 with key and marked as Exhibit "D"
- (v) One blue and purple mobile phone having IMEI no 8691840415738776, 869184041573868 and connection no 7432814172 (vivo). Marked as Exhibit "E".
- (vi) One chocolate color Samsung mobile having IMEI no 350031475729373/01, 354805995729377/01 connection no 8637079799 marked as Exhibit "F"

I, SI Youel Lepcha S/O Jai Tshering Lepcha of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person namely i) Santosh Mahato (36) S/O Lt Nageshwar Mahato of Iskon Mandhir Bashjhar near Munibala School PS Bhaktinagar Dist Jalpaiguri. ii) Rony Ghosh (35) S/O Sailesh Ghosh of Haiderpara Bazar w/n 40 PO Haiderpara PS Bhaktinagar Dist Jalpaiguri to the effect that on 15.02.2024 at 20.25 hrs I, received a reliable specific source input that two persons are standing at Sevoke road opposite of City style, PS Bhaktinagar, Dist Jalpaiguri with illegal narcotic substance to deliver the same to their designed customer. Accordingly, the matter was diarized in General Diary vide Bhakti Nagar PS GDE No 813/24 Dt 15.02.2024 and subsequently, I informed the matter to the Inspector-in-Charge, Bhakti Nagar PS in written. I also informed one Videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist.- Darjeeling over telephone and directed him to come at sevoke road opposite of City style under Bhaktinagar PS with his video camera for the purpose of videography if required. Subsequently, being directed by Inspector-in-Charge, Bhakti Nagar PS, SPC I along with ASI Chandra Prakash Adhikary, ASI Dipak Karmakar, C/ 912 Nakul Ch Singha and C/374 Debraj Biswas all of Bhakti Nagar PS, SPC left for sevoke road opposite of City style PS Bhaktinagar by Govt. vehicle to verify the veracity of the information with investigation kits. This refers to Bhakti Nagar PS GDE No 814/24 dated 15.02.2024 and M.C.C No 485/24 dated 24.02.2024. On the way I briefed all of them and share the information in hand.

Under this circumstances any search warrant or authorization for search cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

At about 21.00 hrs I along with above mentioned officers and force reached sevoke road opposite of City style under Bhaktinagar PS and briefed the two persons who were present there at sevoke road opposite of City style PS Bhaktinagar regarding the information and requested them for accompanying the police team for search and seizure as an independent witnesses. Their name are as follows 1) Pramod Barman (38) (9832030519) S/O Kulin Barman of Shrastinagar Ps Bhaktinagar Dist Jalpaiguri. 2) Lalan Prasad (45) (9832530887) S/O Lt Hari Shankar Prasad of sevoke road opposite of City Style PS Bhaktinagar Dist Jalpaiguri and I issued notice to them in written. At about 21.05 hrs being pointed and identified by the source I, notice the two persons with bags at Marron color Scooty at sevoke road opposite of City style PS Bhaktinagar Accordingly, I along with above noted officers and force cordoned the said place from each corner and manage to detain the suspected persons. Thereafter, we disclosed our identity as police personnel and inform them regarding the information in hand and stated that they will be searched in person for the said purpose.

On being asked the detained persons disclosed their identity as i) Santosh Mahato (36) S/O Lt Nageshwar Mahato of Iskon Mandhir Bashjhar near Munibala School PS Bhaktinagar Dist Jalpaiguri. ii) Rony Ghosh (35) S/O Sailesh Ghosh of Haiderpara Bazar w/n 40 PO Haiderpara PS Bhaktinagar Dist Jalpaiguri and admitted that they have been illegally possessed cough syrup and other narcotics substance for selling the same to their designed customers as per their requirement. I, then gave option to them in writing whether they wanted to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which they agreed to be searched in

...nce of any one of the above. Accordingly, I informed the matter to the I/C, Bhaktinagar Nagar PS and as per his kind order, I informed the fact to Shri Moksedur Rahaman, WBPS, ACP, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, of SPC for the day regarding interception of the accused persons suspected to be possessed illegal narcotics substance and requested him to come at sevoke road opposite of City style PS Bhaktinagar Dist Jalpaiguri to remain present and to supervise the search and seizure as per NDPS norms.

Accordingly at 21.45 hrs Shri Moksedur Rahaman, WBPS, ACP, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate arrived at the spot. Then, I offered the independent witnesses and the detained person to search our Police Party as per provisions of law but they denied to search the police party. Thereafter, in presence of Shri Moksedur Rahaman, WBPS, ACP, Siliguri Police Commissionerate and independent witnesses, I searched the detained persons following all formalities, keeping his strict regard of decency on searched I recovered the above noted articles. On further interrogation they admitted their guilt and stated that they had procured the said 'Codeine Phosphate' based Cough Syrup and tablets clandestinely from one of their supplier for the purpose of selling the same in high rates to their designed customers and also stated that they were waiting for their customer to deliver the same for their personal gain by illegal means and also disclosed that they have been dealing such type of business of procuring and selling of 'narcotics substance illegally for last few months for their wrongful gain.

Accordingly, I seized the following recovered articles are as follows One multi color bag pack style as "TM Sunny Style" containing 65 (sixty five) bottles of "WINCEREX" cough syrup codeine phosphate & Triprolidine Hydrochloride syrup each bottle containing 100 ml, having batch no WCRT1010, MFG date Dec 2023, EXP dated NOV 2025, which was carried by Santosh Mahato and marked as exhibit "A" ii) One Black color gunny bag style as "Premium Rajnigandha" containing 40 (forty) packets of "WINSPASMO FORTE" each packet containing six (6) strips, each strips contains 24 capsules having batch no WPS23033, MFG date Dec 2023, Exp date Nov 2025 and it was carried by or kept at Scooty floor, which is marked as exhibit "B" (40*6=240*24=5760) iii) One black color bag pack style as "American Tourister" containing ten (10) packets of Nitrozone-10 each packet containing 10 (ten) strips and each strips contains 10 (ten) tablet having batch no WN221005, MFG dated Aug 2021, EXP dated July 2024 it was carried by Ronny Ghosh and marked as Exhibit "C" (10*10=100*10=1000) iv) One Marron color scooty (TVS Jupiter) showing number WB 74 AW 1205 with key and marked as Exhibit "D" v) One blue and purple mobile phone having IMEI no 8691840415738776, 869184041573868 and connection no 7432814172 (vivo). Marked as Exhibit "E". vi) One chocolate color Samsung mobile having IMEI no 350031475729373/01, 354805995729377/01 connection no 8637079799 marked as Exhibit "F" under proper seizure list in presence of in presence of Shri Moksedur Rahaman, WBPS, ACP SPC, and independent witnesses and obtain their signature and acknowledged by the accused persons. Subsequently, I sealed and labelled the seized articles in presence of Shri Moksedur Rahaman, WBPS, ACP SPC, independent witnesses and the above noted accused persons. The whole process of search, seizure and label was made under the coverage of videography by the videographer named Somnath Chatterjee S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist.- Darjeeling in between 21.55hrs to 23.25hrs

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons namely i) Santosh Mahato (36) S/O Lt Nageshwar Mahato of Iskon Mandhir Bashjhar near Munibala School PS Bhaktinagar Dist Jalpaiguri. ii) Rony Ghosh (35) S/O Sailesh Ghosh of Haiderpara Bazar w/n 40 PO Haidarpara PS Bhaktinagar Dist Jalpaiguri are involved in procuring and selling 'Codeine Phosphate and other narcotics substance' illegally contravening the norms of NDPS Act. Then, I arrested the above noted accused persons namely i) Santosh Mahato (36) S/O Lt Nageshwar Mahato of Iskon Mandhir Bashjhar near Munibala School PS Bhaktinagar Dist Jalpaiguri. ii) Rony Ghosh (35) S/O Sailesh Ghosh of Haiderpara Bazar w/n 40 PO Haidarpara PS Bhaktinagar Dist Jalpaiguri after observing all formalities and informing the ground of their arrest and issued proper Memo of Arrest.

Under the above circumstances, I pray before you that a specific case under proper section of law may kindly be started against the following arrested accused persons namely i) Santosh Mahato (36) S/O Lt Nageshwar Mahato of Iskon Mandhir Bashjhar near Munibala School PS Bhaktinagar Dist Jalpaiguri. ii) Rony Ghosh (35) S/O Sailesh Ghosh of Haiderpara Bazar w/n 40 PO Haidarpara PS Bhaktinagar Dist Jalpaiguri and arrange for its investigation.
