- I, **SANYUKTA MOITRA**, W/O Dheeraj Gupta, R/o M.N.Sarkar Road, Ward No. 6 of S.M.C., Mahananda Para, P.O. & P.S. Siliguri, Dist-Darjeeling, do hereby would like to inform you as follows:-
 - 1. That my husband namely Mr. Dheeraj Gupta, S/o Late Mohan Lal Gupta, is the Proprietor of a reputed Advertising Agency in Siliguri
 - 2. That during the course of the business of my husband namely Mr.Dheeraj Gupta, S/o Late Mohan Lal Gupta, one Mr. Rachit Agarwal, Director of Musafiri Adworks, S/o Mr.Sandeep Agarwal, Resident of Saralia Market, Shivaji Road, Ward No.8, Khalpara, P.O & P.S.Siliguri, approached my husband namely Mr.Dheeraj Gupta, S/o Late Mohan Lal Gupta to trade his hoardings to the prospective clients of Siliguri for the purpose of advertising their products in exchange of a certain amount of commission.
 - 3. That subsequently the dealings between my husband namely Mr.Dheeraj Gupta, S/o Late Mohan Lal Gupta and the said Mr. Rachit Agarwal, Director of Musafiri Adworks, S/o Mr.Sandeep Agarwal suffered a huge setback when the said Mr. Rachit Agarwal, Director of Musafiri Adworks, S/o Mr. Sandeep Agarwal failed to pay the dues on time and demanded waive-offs and started to blackmail my husband namely Mr. Dheeraj Gupta, S/o Late Mohan Lal Gupta that if we do not pay him Rs. 5,00,000/- (Rupees Five Lakh) only then the said Mr. Rachit Agarwal, Director of Musafiri Adworks, S/o Mr.Sandeep Agarwal will implicate us in false cases and will defame us in social media by spreading rumours and will also destroy our business.

4. That thereafter, my husband namely Mr. Dheeraj Gupta, S/o Late Mohan Lal Gupta decided to discontinue his association with Mr.

- 5. That subsequently the said Mr. Rachit Agarwal, Director of Musafiri Adworks, S/o Mr. Sandeep Agarwal, became violent and thereafter on 2nd of February 2024, Mr. Agarwal continuously started sending unpleasant and obnoxious messages over WhatsApp (which he has deleted recently), text messages, and emails (printout of the messages attached herewith) to my husband and his employees with the intention of defaming us.
- 6. That subsequently on 5th of February, 2024, Mr. Rachit Agarwal, Director of Musafiri Adworks, S/o Mr. Sandeep Agarwal had again sent an abusive message about me to the employees of my husband namely Mr. Dheeraj Gupta, S/o Late Mohan Lal Gupta, which was being informed to me by a female employee who is also the recipient of the message circulated.
- 7. That I somehow, managed to recover the deleted message from one of the numbers sent by Mr.Rachit Agarwal, Director of Musafiri Adworks, S/o Mr.Sandeep Agarwal, and successfully recovered the same from one of the employees, a printout of which is submitted herewith. The derogatory message is an utter attack on my character and reputation. It violates my right to live with dignity as a citizen of India. Mr.Rachit Agarwal, Director of Musafiri Adworks, S/o Mr.Sandeep Agarwal has intentionally circulated the message to my husband's employees with the intention to extort money from my husband.
- 8. That when my husband protested the same the said Mr. Rachit Agarwal, Director of Musafiri Adworks, S/o Mr. Sandeep Agarwal, threatened us with dire consequences and made a deliberate attack by spreading rumours with regard to my character to my close employees with whom I am acquainted with an intention to insult and outrage my

modesty in society and destroy the social prestige that I have earned over the years.

I am in a state of shock and fear and anticipate that Mr. Rachit Agarwal, Director of Musafiri Adworks, S/o Mr.Sandeep Agarwal's can go to any extent to harm us.

I therefore request before your good self to kindly look into the matter and take strict necessary action against the said Mr. Rachit Agarwal, Director of Musafiri Adworks, S/o Mr.Sandeep Agarwal, as per the provisions of law and for this act of kindness I shall remain extremely grateful to you.
