Sub: Complaint against my husband Md. Nasrul Haque Son of Md Nasim Haque, Father-in- law Md Nasim s/o not known, Mother-in-law Munni Begam Wife of Md. Nasim Haque and brother-in-law Md Nurul S/o Md Nasim Haque.

Respected Sir,

I, Smt. Taslima Khatoon, Wife of Md. Nasrul Haque, presently residing at koila dipo ward No 7 of S.M.C P.S Siliguri, Dist- Darjeeling, do hereby lodge a complaint against my husband Md. Nasrul Haque Son of Md Nasim Haque, Father-in- law Md Nasim s/o not known, Mother-in-law Munni Begam Wife of Md. Nasim Haque and brother-in-law Md Nurul S/o Md Nasim Haque resident of Kholai Bhaktari, Tomba Jote, Matigara, P.O. and P.S. Matigara, Dist. Darjeeling, to the effects as follows:-

- (1) That my marriage was solemnized in the year, 2012 along with said Md. Nasrul Haque as per Mohammedan Law and custom and said marriage was registered as per Muslim Marriage Act.
- (2) That out of the said wedlock, I gave birth to a one male child now aged about 10 years namely Sagir Ahmed and one female child namely Nehra Khatoon now aged about 5 years.
- (3) That since after the said marriage, my husband and in-laws are use to demand me to bring money and scooty from my parents and my parents anyhow manage to give him Rs.50,000/- and scooty to my husband.
- (4) That again after few months, my husband demanded me to bring more money and also mobile phone, my parents for the betterment of our conjugal life gave 1,00,000/- to him.
- (5) That when my parents refused to give him more money as per his demand then my husband use to abuse me in filthy and slang languages and use to torture upon me both mentally and physically.

- (6) That my husband have an illicit relation with many woman when I protested said illegal activity my husband with instigation of my in-laws, he used to regular inhuman torture both mentally and physically.
- (7) That in the year 2018, my husband and in-laws forcefully ousted me and my children from my matrimonial home and I was compelled to take shelter at the house of my parents.
- (8) That since marriage and since birth of my son, my husband did not maintained properly and sufficiently to me and my children.
- (9) That my husband always threatens to kill me and frequently come with my parental home and physically assaults me with fist and blows slaps, kick and demanded more money from my parents when my parents refused to give him more money as they are very poor as per his demand then he use to abuse me in filthy and slang languages and use to torture upon me both at my parental home.
- (10) That again today on 11-02-2024 at about 7p.m he came to my parental home demanded more money and abused me in obscene and filthy languages with intention to kill me he throttled my neck and physically assaulted me with blows and slaps on my stomach and pushed me thereafter I fell down on the floor due to which I sustain injury on my forehead and stomach and thereafter I became a senseless condition, then my parents took me to the Siliguri District Hospital.

So, therefore, I humbly request you take stringent legal action against my said husband and at an earliest.

I shall remain ever grateful for the needful and be obliged thereby.
