I Sahab Das, the above noted complainant
beg to inform you that on Dt. 12.02.2024 I
about 10:30 am, I received a call from mobile
No. 7319079985, over my my mobile Number,
9832610034, when I was at my shop at
Amlapatry, 1 No Railgate, and the said caller
told me that he is speaking from the shop
namely M/s Amarjyoti, 3rd Floor, Golden Plaza,
Burdwan Road, Siliguri and ordered some
goods over the phone and told me that he is
sending his employee namely, Sonu Ray,
and later on, one person introduced him as
sonu Ray, coming to my shop & requested me to
supply the articles. Since said M/s Amarjyoti
is our old customer, I trusted said sonu Ray
and supplied, the following kitchen utensils
& other goods on credit as per their order, viz
(1) Mixture (2 jars) - ~~1 pc~~ costing Rs. 1350/- (2)
Mixture 2 Jar - 1 pc - Rs. 1000/-, (3) Usha Mixture -
8 pc - Rs. 2000/- (4) Swage cooker - 5 ltrs - 4 pc - Rs.
1350/- (5) Mixture Usha - 7 pc - Rs. 2100/- (6) Century
cooker - 5 ~~litrs~~ ltrs - 5 pc - Rs. 720/- (7) Mintage HotPot
20 ltrs - 3 pc - Rs. 2400/- and (8) Swage Cooker - 3 ltrs -
4 pc - Rs. 1150/- which total amounting to Rs. 57663/-
(Rupees fifty seven thousands six hundred sixty three)
only, and the said sonu Ray & his associates
taken away the said goods after issuing the
chellan by me for said goods

Later on when I went to M/s Amarjyoti at
Golden Plaza, I came to know that said supplied
goods were not received by the said M/s Amarjyoti

So, please take necessary action against said
