Sir,

In producing herewith one arrested accused person named Mithu Roy (20 yrs) S/O Malin Roy of Gurung Busty, Durga Nagar, Ward No-03, PS- Pradhan Nagar, Dist.- Darjeeling PS- Pradhan Nagar, Dist.- Darjeeling under arrest along with following articles under proper seizure list. The ground of arrest duly been communicated with him.

- (i) 15 (fifteen) bottles of 60 up Himalayan Gold India made liquor containing 600 ml in each bottle i.e. total (15 x 600) = 09 ltrs which was kept in a nylon bag and marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A1".

I, ASI Biplab Kr Das of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person named Mithu Roy (yrs) S/O Malin Roy of Gurung Busty, Durga Nagar, Ward No-03, PS- Pradhan Nagar, Dist.- Darjeeling to the effect that on 16.02.2024 at 19.10 hrs. myself along with force left the PS to perform Mobile Van duty vide Pradhan Nagar PS GDE No 1151 dated 16.02.2024. During my patrolling duty I received a specific source information that one person named Mithu Roy of Gurung Busty is selling illicit liquor at his residence without any valid license. Accordingly, I informed the matter to the I/C PS who directed me to verify the veracity of the information. As per his kind order and direction, I along with force held raid at the house of above noted accused namely Mithu Roy of Gurung Busty and managed to apprehend him. On being asked he disclosed his identity as noted above and also disclosed that he is storing illicit liquor illegally to sale the same in higher price for his wrongful gain. On being search the above noted seized articles were found in his possession. On demand he failed to produce any valid license/papers for selling and storing of such illegal liquor. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license since long for his illegal gain. Then, I seized and labeled the above mentioned illegal illicit distilled liquor under proper seizure list from his possession and subsequently, arrested the above mentioned detained person namely Mithu Roy (20 yrs) S/O Malin Roy of Gurung Busty, Durga Nagar, Ward No-03, PS- Pradhan Nagar, Dist.- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 21.05 to 21.45 at the spot for violating the norms of Bengal Excise Act.

I, therefore pray before your good self that a specific case may kindly be initiated against accused namely Mithu Roy (20 yrs) S/O Malin Roy of Gurung Busty, Durga Nagar, Ward No-03, PS- Pradhan Nagar, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
