I, Sri Manoj Paul, Assistant Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Subrata Chakraborty, Bharati Bhawan, Lala Lajpat Roy Road, Ashram Para, Siliguri, Dist- Darjeeling for having committed offence as stated here under.

On 15.02.2024 at about 02.05 p.m. acting on a source information I, along with 1) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (2) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the residential building of Subrata Chakraborty and inspected service installation, metering installation of Consumer ID 412025480 in the name of Subrata Chakraborty. During inspection it was found that electricity was being used from existing domestic connection unauthorisedly & illegally for commercial purpose.

As unauthorised commercial uses from domestic service connection was detected the energy meter make Bentec Electricals & Elec Ltd, serial no.- IPB257556 installed against Con Id. 412025480 seized by preparing a formal seizure list duly signed by representative of Subrata Chakraborty and witnesses. The copy of the seizure list handed over to representative of Subrata Chakraborty and his signature obtained as token of receipt.

As Subrata Chakraborty have committed offence u/s 135(1)(e) of Electricity Act 2003 by using electricity illegally & unauthorisedly for commercial purpose from domestic connection, you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
