In producing herewith (05) five accused persons namely (i) Md Mojabil (24 yrs) S/O Late Md Atabul of New Pokaijote, PS- Pradhan Nagar, Dist.- Darjeeling (ii) Md Firoj (27 yrs) S/O Md Ainul of 8 th mile, near Petrol Pump, PO+PS- Kalimpong, Dist.- Kalimpong (iii) Arbin Pradhan (30 yrs) S/O Gobin Pradhan of Ghoom, Starling, PS- Jorebanglow, Dist.- Darjeeling (iv) Md Allauddin (22 yrs) S/O Lt Md Hafiz of Ratanlal Busty, Mallaguri, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling and (v) Amit Balmiki (32 yrs) S/O Late Rotaj Balmiki of Dhaknikata, near Murga Larai Math, PS- Pradhan Nagar, Dist.- Darjeeling under arrest and the following articles under seizure:-

Accordingly, I informed the matter to the I/C, Pradhan Nagar PS and diarized the fact in General diary vide Pradhan Nagar PS GDE No. 1166 dated 16.02.2024. After getting the permission from the I/C, Pradhan Nagar PS myself along with SI Bandhan Roy, ASI Biplab Kr. Das, C/1411 Ashok Roy, C/1413 Sujit Sarkar, C/1415 Chandan Basak and C/1416 Dilip Barman all of Pradhan Nagar PS left for Ram Narayan Math, Bagha Jatin Colony under Pradhan Nagar PS to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of climax of the situation and not to afford them opportunity for the concealment of evidence or facility for their escape. On the way, I informed the matter to RT van officer ASI M. S. Alam of Pradhan Nagar PS and directed him to come at Ram Narayan Math, Bagha Jatin Colony to accompany with us for holding raid at Mahananda river Bed, near Ram Narayan Math, Bagha Jatin Colony. At about 22.05 hrs we reached at Ram Narayan Math, Bagha Jatin Colony and after few time, ASI M.S. Alam along with his force arrived at Ram Narayan Math and accompanied us. Thereafter, I contacted with my source and as pointed by the source we noticed that 11/12 persons assembled at Mahananda River Bed beside Ram Narayan Math and they were whispering in a very low voice. We cordoned the place with due care and caution.

On seeing police personnel approaching towards them they tried to flec away from the spot but on hot chase we managed to apprehend above noted five (05) accused persons with deadly weapons in their possessions while 05/06 others managed to flee away from the spot taking the opportunity of darkkness by crossing river Mahananda. On interrogation, they disclosed their identities as noted above. On further interrogation they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with their associates assembled there and were making preparation for committing dacoity at Bagha Jatin Colony area. Accordingly, I seized the above mentioned weapons of offence from their possessions under proper seizure list in between 22.35 hrs to 23.30 hrs duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed over the ground of arrest. I accordingly brought all the five (05) arrested accused persons along with seized article at Pradhan Nagar Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they along with their associates assembled there and making preparation for committing dacoity at Bagha Jatin colony area.

From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted 05 accused persons along with others who fied away gathered there equipped with deadly weapons at such dead hour of night for taking preparation to commit dacoity in a nearby affluent area at Bagha Jatin Colony.
