Ghosh of Panitanki TOP-1 PS Siliguri/DJL on point of jurisdiction. Sir,

In producing herewith one arrested accused person namely Uttam Das (54) S/O Lt. Balahari Das of Rabindranagar More, W/No. 22, PS-Siliguri, Dist-Darjeeling along with following seized articles-

(1) 10 (Ten) Bottles of Country Spirit styled as 'Himalayan Gold' 60° UP containing 600 ml each, MRP Rs. 155/- and

(2) One Nylon Bag which used for carrying the seized articles SL. No. 1.

I, ASI Surojit Mallick of Panitanki TOP under Siliguri PS hereby lodge a written complaint against the above noted accused person to the effect that on 15.02.2024 at 23.15 hrs received information from secret source to the effect that one person is stored huge quantity of bottled country spirit in a nylon bag near Bidhan Market Auto stand and selling the same to his designated customer of Bidhan Market. Accordingly the information was diarized vide Panitanki TOP GDE No. 344 dated 15.02.2024 and conveyed the same to O.C., Panitanki TOP and thereafter as per his direction I along with van officer ASI Lakshan Kr. Singha, C/739 Dilip Mitra, CV-377 Dinesh Roy left from Panitanki TOP to work out the information. On arrival near Bidhan Market Auto stand being pointed out by the source, found that one person is possessing huge quantity of country spirit in a nylon bag and sell it to the local customer. Accordingly we intercepted the said accused person and apprehended him with loaded articles. Therefore we searched him in presence of disinterested witnesses namely (1) Jiten Sha s/o Lt. Laxmi Sah of Vidhyachakra Colony, Ward no-44, PS-Bhaktinagar, Dist-Jalpaiguri and 2) Debajayti Maity s/o Probal kr Maity of Vidhyachakra Colony, Ward no-44, PS-Bhaktinagar, Dist-Jalpaiguri and recovered 10 (Ten) Bottles of Country Spirit styled as 'Himalayan Gold' 60° UP containing 600 ml each, MRP Rs. 155/- which is stored in a nylon bag. During interrogation the accused failed to produce any documents/license in support of the same and disclosed his identity as Balahari Das of Rabindranagar More, W/No. 22, PS-Siliguri, Dist-Darjeeling and also stated that he sells the same illegally to the local customer at Bidhan market area with a view to earn huge money for his lively hood. Accordingly, I (1) 10 (Ten) Bottles of Country Spirit styled as 'Himalayan Gold' 60° UP containing 600 ml each, MRP Rs. 155/- and (2) One Nylon Bag which used for carrying the seized articles SL. No. 1. under proper seizure list and labeled the same in presence of the above noted witnesses and duly sign by them and also by the accused person. The seizure was made between 23.45 hrs. to next day 00.00 hrs. I, then arrested the said accused person u/s 41 Cr.P.C. after explaining charge against him. The local public was also annoyed with him because of his this kind of illegal activities.

Hence, under the above noted circumstances I am submitting this written complaint against the above accused person namely Uttam Das (54) S/O Lt. Balahari Das of Rabindranagar More, W/No. 22, PS-Siliguri, Dist-Darjeeling for starting a specific case under proper section of Law and to arrange for its investigation.
