I, Sri Sushanta Paul (Ph No. 9800452233), both sons of Sri Abhinash Paul, resident of Dhantala, P.O. Dhantala, P.S. Islampur, Dist. Uttar Dinajpur, PIN - 732113, am the rightful and legal owner of the plot of land with following description: 15 decimal or 8 Katha 13 Chhatak 36 Sq. Ft. land appertaining to Plot No. 368 (R.S.), 711 (L.R.) Khatian No. 3342 and 3336 (L.R.), Mouza - Rangia, Pargana - Patharghata, P.S. Matigara, Dist. Darjeeling, J.L. No - 66, Touzi No 91, have been owning and possessing the registered land for 6 years, since 2018.

Sir, we would like to bring to your notice about the following incidents occurred:

- On 18.01.2024, at around 12:00 PM two miscreants named **1. Dhiraj Singha** (Ph No. 6295089945), S/O Robin Singha and **2. Robin Singha** S/O Late. Dhula Singha, both residents of Vill. New Rangia Jote, P.O. New Rangia, P.S. Matigara, Dist. Darjeeling trespassed and broke into our private land along with a bulldozer and many other men.
- The said land is registered in our name and we have been permanently residing here for 6 years since 2018.
- The land has boundary from 3 sides. They started to demolish & dig the front area of our land and even the central part of it. When we confronted the two miscreants, they threatened us of our life by saying they will burn down our houses and kill us.



They took me in the vehicle and went to a house of an unidentified person at Sadhan More and kept me locked inside that house for 2 Hours and demanded Rs. 18,00,000/- from me or asked me to hand over my land to them which is my own registered private land continuously also threatened me as if I did not do as asked by them, I would face dire consequences and that they would take away my life and my land. After 2 hours of torture, they left me free and dropped me at a location near my house in which I was at Trauma and got no strength to stand in my feet.

Sir, I am highly disturbed, threatened and afraid of life as after this incident I am not being able to freely move out of my house and I am afraid that my legally registered land will be taken away by the above-named miscreants and their men and they would kill me and torture my family.

In view of the above narrated facts and circumstances, I request you to take necessary legal steps and thereby save my life and my property from illegal and unlawful attempts.
