Sir,

I, Rahul Kumar @ Rahul Kumar Singh, Son of Dayanand Prasad Singh, resident of Rabinsen Colony . P.O. & P.S. Matigara, District -Darjeeling, Pin- 734010, would like to inform you that my wife namely, Tarunnum Parveen in conspiracy with Siddiqui Sahadat, S/o Lt. Shahadat Hussain, both residing at Sahadat Mention, Sipahi Para, Chatarganj, Optical factory, Near Poultry Farm and Uttar Kanya, District -Jalpaiguri .is continuously threatening me of dire consequences and I fear for my life and limb.

That on 16th October, 2023 my wife gave a threatening message from her mobile number 94740-33603 in my whatsapp number, that is, 7908310619. that she would lodge false cases against me and make my life hell. She threatened me by stating that - ".....avi to utna case kiye hi nahi..sirf 498 se kya hoga tum bail leke nikal gaye to kya avi hum roj tumpar case karengemera gussa khatam nahi hoga jab tak tumhara jaan na le le..jindagi bhar jail mein tujhe chaki na piswai to mera na tarunnum nahi....itna case denge tumhe ki jundagi bhar dourte dourte khatam ho jayegi..aur tum kuch nahi kar paoge..larko ke liye koi kanoon nahi hota hum pata laga liye har jagah meri hi baat suni jayegi...".

That I have the said message and also the bank statement from where her number can be verified.

Immediately, after this she planned a conspiracy with Siddique Sahadat and her three sisters namely, Sabnam Parveen, W/o Samjad Ali, Shama Parveen, (w/o Subhan Ali), Tabassum Praveen (W/o Siddiqui Sahadat) and brother namely, Khali Lullah Sheikh, S/o Habibullah Shiekh, to lodge a false case against me and with that intent she came to Siliguri Court on 25.1.2024 that is, (the date on which my case was there in Siliguri Court before the Learned A.C.J.M. vide Misc Petition case no. 68/2023 which was initiated against her and her other relatives as mentioned above), and all of a sudden approached me and started to slap me twice and thrice and when I tried to stop her by stopping her hands, she hit me on my private part and deliberately started to raise allegations against me to gather crowd falsely saying that I have assaulted her. That there were witnesses in Court who saw the entire incident and for help I called my advocate and on inquiry from people standing there my advocate also came to know that assault was from the side of my wife. Therefore, my advocate verbally complained A.C.J.M. about the incident where Misc petition case no. 68/2023 was heard and after informing the ACJM on the same date itself on 25.1.2024, I lodged a criminal complaint against my wife and others regarding the incident of assault, false blame on me and also threat by my wife, Sabnam Parveen and Khali Lullah. I filed the complaint along with my medical report vide C.R. Case No. 175/2024.

That my wife also lodged false FIR against me vide Siliguri P.S. Case no. 77/2024 to fulfil her ill motive to execute her threats which she gave via whatsapp message on 16th October, 2023. That my wife did not have any matter in court on the relevant day of 25.1.2024 and she deliberately came to court with ill intent of creating a scene and lodging false case against me. I doubt that it must be on the guidance of someone from legal field who must have informed my wife about my date in court and everything was pre-planned.
