Sir,

In producing herewith one arrested accused person namely Rohit Karmakar-20yrs s/o Lt Motilal Karmakar of Tikiapara Matangini colony-II, ward No-28 PS Siliguri Dist Darjeeling along with the following seized articles as per proper seizure list viz:

- (1) 12 (Twelve) pet bottles of Himalayan Gold 60up country spirit (India made) Manufactured by Himalayan Endeavour Pvt Ltd. (Each bottle containing 650 ML) which was kept in one big nylon hand bag.

I, ASI Debasish Das of Siliguri PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 16.02.24 at 21.05 hrs received a source information from Matangini colony-II under Siliguri PS that one person namely Rohit Karmakar has gathered huge quantity of liquor in his street hotel at Matangini colony for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Siliguri PS GDE No-852 dated 16.02.24. As per your kind instruction I along with ASI Subir Sen, CVF /622 Ramanath Barman & CVF /283 Prasenjit Dey proceeded to the PO to work out the information. At 21.20 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his street shop which was kept in the shop of him. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him u/s 41 Crpc after issuing proper arrest memo (The seizure was made in between 21.40 hrs to 22.20 hrs)

I therefore request you a specific case may kindly be started against the accused person namely Rohit Karmakar-20yrs s/o Lt Motilal Karmakar of Tikiapara Matangini colony-II, ward No-28 PS Siliguri Dist Darjeeling under proper section of law and arrange for investigation..
