Sir,

In producing herewith (04) four arrested accused persons namely (1) Promod Sahani-30yrs s/o Akhil Sahani of Hatat colony, Tikiapara ward No-28 PS Siliguri Dist Darjeeling (2) Dulal Biswas-31yrs s/o Sudhir Biswas of Kankata More, Panganipara PO Shantinagar PS Bhaktinagar Dist Jalpaiguri and (3) Sanjib Das @ Doga-21yrs s/o Sambhu Das of Chittaranjan colony, ward No-20 PS Siliguri Dist Darjeeling and (4) Md Ali-22yrs s/o Nur Mahammad of Hatat colony, Tikiapara, ward No-28 PS Siliguri Dist Darjeeling arrested on 17.02.24 u/s- 41 Cr.P.C along with following seized articles viz: -

1. One iron rod measuring about 20 inch (approx) from the possession of accused Promod Sahani which was kept on his right hand.
2. One iron rod measuring about 22 inch (approx) from the possession of accused Sanjib Das @ Doga which was kept on his right hand.
3. One iron made Knife approx 8 inch from the possession of accused Dulal Biswas which was kept on his right waist.
4. One iron made Knife approx 7 inch from the possession of accused Md Ali which was kept on his right waist.

I, SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Siliguri Police station under Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others to the effect that, on 17.02.24 at 00.05 hrs received a sources information that 7/8 youths have assembled at near Air view more bus stand behind Howrah petrol pump under Siliguri PS for making preparation to commit dacoity in a house at Siliguri PS area. The fact was diarized in G.D vide Siliguri PS GDE No. 879 dated 17.02.24 Subsequently after sharing the information with my superiors and as per their direction, at 00.10 hrs myself along with PSI Koushik Raha, ASI Debasish Das, ASI Subir Sen, CVF/622 Ramanath Barman & CVF/283 Prasenjit Dey along with kits left for the place to work out the information. This refers to Siliguri PS G.D.E No 880 dated 17.02.24. We reached at near Air view more bus stand behind Howrah petrol pump under Siliguri PS at 00.00.15 hrs and subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from that Place. Sensing the police has cordoned off, they tried to flee away but on hot chase we managed to apprehend above noted 04 (four) accused persons along with seized articles as mentioned

above. However, the other four persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Siliguri PS area. They also stated that another four others fled away from the spot.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the Witnesses and acknowledged by the accused persons. (The whole seizure was made in between 01.20 hrs to 02.10 hrs) Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of arrest memo to them.

I accordingly brought the arrested accused persons along with seized article at Siliguri Police Station for further investigation. During interrogation, they are stated that they are gathered there to commit Dacoity in a house at Siliguri PS area.

Hence, I pray before your good self that, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (1) Promod Sahani-30yrs s/o Akhil Sahani of Hatat colony, Tikiapara ward No-28 PS Siliguri Dist Darjeeling (2) Dulal Biswas-31yrs s/o Sudhir Biswas of Kankata More, Panganipara PO Shantinagar PS Bhaktinagar Dist Jalpaiguri and (3) Sanjib Das @ Doga-21yrs s/o Sambhu Das of Chittaranjan colony, ward No-20, PS Siliguri Dist Darjeeling (4) Md Ali-22yrs s/o Nur Mahammad of Hatat colony, Tikiapara, ward No-28 PS Siliguri Dist Darjeeling and four others and arrange for its investigation.
