I Sri Sunil Lama , Station Manager, NJP Gate Bazar CCC, WBSEDCL, hereby lodge a Complaint against Dharam Raj Roy, son of Unknown at NJP VIP Road, PO-Bhaktinagar, PS-NJP , for unauthorizedly reconnecting deemed disconnected meter iro consumer id - 402270428 as liable u/s 135/1(a) & 138/1(b) of electricity act 2003 & Amendment act 2007.

On dated 12.02.2024 at about 14:35 hrs , I along with 1) Sri Pranab Sikdar, SO, S & LP is from Darjeeling Regional Office, WBSEDCL, and other officials of WBSEDCL visited the premises of said above for inspection. During inspection it was found that unauthorized electricity consumption iro consumer id - 402270428 with meter no: B5060358 as liable u/s 135/1(a) & 138/1(b) of electricity act 2003 & Amendment act 2007. The Service connection stands in the name of Shri Md.Samir but Present user of the site is Shri Dharam Raj Roy as stated by the present tenant of the premises Shri.Bimal Bhattacharjee.

As the dishonest use of electricity is detected, the service connection has been disconnected and removal of Meter vide Meter No - B5060358 with PP Box & other details separate sheet are enclosed herewith. The above articles has been seized by me by preparing a formal seizure list duly signed by the present user in the premises.

Dharam Raj Roy, son of Unknown at NJP VIP Road, PO-Bhaktinagar, PS-NJP P.S- NJP has committed an offence u/s 135/1(a) & 138/1(b) of Electricity act 2003. You are requested to take cognizance of the same by treating this complaint as an F.I.R.
