I given my two small shop in rent for living my life after the death of my husband I live in alone at my home. Sir my house get old due to which in rainy season I face many problems so become the rainy season I have decided to construct new pucca house after demolished my old house my house already demolished and new construction work gone started but my neighbour sri Ramesh ch prasad along his cousin brother sri Awadhesh prasad come to my house many times with badly intention without any permission when I was alone at my house they always pressurised me to sale them my property many times I have complaint to their family but they did not do anything. on dated 15 Feb 2024 around 2 pm they both come near me when I stand at vivekanand road and say me that I have to spend whole night with them in a separate room I denied and told them that I am shouting if you are saying again this sentence but they threatened me that they have much power to stop my construction of my house and implicated false complaint against me in administrtion after they back to their house now they are spreading false allegation against me that I am doing job like a call girl. Sir I am very poor nobody can help me they try to sale my property by pressuring on me, so sir it's my humble request to you that please take strict action against both persons and do the necessary step for the justice
