With due respect, I am producing herewith one accused person namely Promod Sha (36) s/o Lt. Ram Prabesh Sha of Rabindra Nagar, PS Bagdogra, Dist. Darjeeling brought under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 12 (Twelve) bottles of Himalayan Gold Country Spirit (each bottle containing 600 ml,)

I, SI Samik Paul presently attached with BDR PS under your kind control beg to state that today i.e. on 16.02.2024 at 17.55 hrs I received a secret source information that one person namely Promod Sha (36) s/o Lt. Ram Prabesh Sha of Rabindra Nagar, PS Bagdogra, Dist. Darjeeling is selling ID liquor illegally at his shop situated at Hatkhola Bazar under PS-BDR, Dist.-Darjeelig. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 803 dated 16.02.2024 and informed the fact to you. As per your kind direction and instruction myself along with ASI Munna Ahamed, ASI Amit Lama all of BDR PS, SPC left for Hatkhola Bazar under PS-BDR, Dist.- Darjeeling to work out the information in hand. At about 18.30 hrs we arrived Hatkhola Baza, PS-BDR, Dist.- Darjeeling and being identified by the source I found the said accused person selling Illegal Distilled liquor to regular customers at his shop and hold raid at his shop and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure and arrest was made in between 18.35 hrs to 19.05 hrs

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the accused namely Promod Sha (36) s/o Lt. Ram Prabesh Sha of Rabindra Nagar, PS Bagdogra, Dist. Darjeeling and arrange for its investigation.
