SUB:- FIRST INFORMATION REPORT AGAINST RAJENDRA AGARWAL, SON OF LATE ASHARAM AGARWAL, RESIDENT OF 134 BY LANE, RAMKRISHNA ROAD, ASHRAM PARA, PO & PS. SILIGURI FOR ABUSING ME WITH FILTHY LANGUAGE, PHYSICALLY ASSAULTING ME AND ATTEMPT TO OUTRAGE MY MODESTY.

RESPECTED SIR,

I, Smt. Madhumita Ghosh, Daughter of Late Bidhan Chandra Ghosh, Resident INDRANI BHAWAN, situated at Loknath Sarani, Mahananda Para, HillCart Road, P.O. and P.S. Siliguri, Dist-Darjeeling, Pin-734001, within the State of West Bengal bring to your notice the following facts

My father Bidhan Chandra Ghosh since deceased was the absolute owner of one 4 stored building commonly known as INDRANI BHAWAN, situated at Loknath Sarani, HillCart Road, P.O. and P.S. Siliguri which he had during his lifetime bequeath in favoured of my mother by way of a Registered Will and after his demise the said Probate of will was granted in favour of my mother by the competent Court and as such by the dint of the said Probate my mother Smt. Papiya Ghosh became absolute owner of the property mentioned above.

My late father during his lifetime has inducted tenants in the said property was let out and monthly rent was fixed in according to the prevailing market rate according to that time. After the death of my father my mother requested the tenants to execute fresh tenancy agreement with her as the existing tenancy agreement were between the tenants and my father (Since deceased).

That on receiving such request the tenants became agitated and agree and stated to threaten us and my family. That today one money order was sent to our address by one of the tenant namely Rajendra Agarwal, Son of Late Asharam Agarwal, Resident Of 134 By Lane, Ramkrishna Road, Ashram Para, Po & Ps. Siliguri tendering the old rate of rent and as such the same was refused by my mother.

The said incident has angered the said tenant namely Rajendra Agarwal, Son of Late Asharam Agarwal and as such around 7 P.M. in the evening he came to our premises and I asked him politely to leave our premises and said him to come to come back in morning for discussion. In reply of the same he started using utmost filthy language using unspeakable words to a lady making lewd and obscene gestures and ultimately pushed me hard by locking his both palms on my chest, caught hold of my dress and yanked it.

I sougheed for help with sheer fear and apprehension and hearing my shouts, my brother namely Biswarup Ghosh, Son of Late Bidhan Chandra Ghosh rushed down to rescue me and on seeing my brother rushing towards me the said person fled the place.

Due to such unwarranted incident I became very much shaken and unwell. After that my brother and sister nursed me for some time and I regained my self and I decided to report the matter to your good self.

I therefore, request you to initiate immediate action by starting one criminal case against the said Rajendra Agarwal, Son of Late Asharam Agarwal, Resident of 134 By Lane, Ramkrishna Road, Ashram Para, Po & Ps. Siliguri and to punish him in accordance with law.
