Sir,

I, Bikash Kumar Saha, the above noted complainant beg to inform you that on dt. 22.02.2024 at about 00:20 hrs, when my truck (Tata Ace) bearing Regd. No. WB-69-4338 (Regd. owner Sanjit Barman, S/o Jagdish Barman, of Anil Nagar, P.S-Matiguri, Distt - Darjeeling) driven by my driver namely Biplob Ghosh S/o Santosh Ghosh of Keshindra Nagar, P.S-Matiguri, reached at Ramghat, Nariyapara, and No. 5 sme, P.S-Siliguri, at that time, other trucks loaded with sand & stones, bearing Regd. No. WB-73-9645 & WB-73-2549, of our group reached there, and all the trucks loaded with sand & stones, were stopped by the above noted address alleged persons namely Tulai Puroan (2) Bapi (3) Chhotu (4) Abdali (5) Nantu & 4 to 5 unknown persons of their group, got down from a car (Swift drive) white colour, bearing Regd. No. WB-74-X-9913 display a board written as on Government duty on the said car, and they stopped our vehicles and started demanding extortion money from my trucks & from others, when my said driver & the driver of other truck denied to pay the extortion money, they started abusing the drivers and when the driver of the truck bearing Regd. No. WB-73-9645, namely Atulash Pradhan, called his truck owner namely Vilash Barman S/o Suresh Barman, of Ranapagar, Near Pappu Ghat, P.S-Matiguri and he alongwith other laborer namely, Ashim Roy (2), Tanu Barman & (3) Robin Saha, protested they took out deadly weapons, like Dora (sharp cutting iron made weapon), iron rods, lathis from their car and attacked on Vilash Barman, Ashim Roy, Tanu Barman & Robin Saha, and they received severe injury on their persons & when we called the police, the night mobile Van came from Khalpara T.O.P II and interfere into the matter, then the above noted alleged persons who attacked on said Khalpara Night mobile Van & other police personnel including P.T.O. p.p.O.

And when the Khatpura T.O.P.D., night mobile van officers informed to Khatpura T.O.P.D., more police force came there and took action than the above noted alleged persons managed to escape from there.

Sir, it is pertinent to say that me and other truck owner used to carry sand & stones (Building material) regularly from the ghel of Smt. Pramila Yadav, called Pappu Ghel, Ramu Nayari, P.S. Meligani Distt-Darjeeling, and since long time, the above noted alleged persons, who are originally the anti-social persons, were demanding monthly extortion money from, we all truck owner & Drivers, of said line, but since we were unable to pay them Rs. 2000/- (Two thousand) only, from each truck, monthly to them, we avoided the Ramghat route & used to come through Thakur More route, but since few days, we were using Ramghat route, because we heard that they are not there but today they caught my truck and other trucks and demanded the extortion money.

Sir, so please take necessary action against above noted alleged persons, because Vilash Barman, Ashim Ray, Tanu Barman & Robin Saha, immediately shifted to Siliguri Distt-Hospital and treated there and, said Vilash Barman has been admitted to Siliguri Distt-Hospital in serious condition.
