Asmita Chakraborty, Wife of Sri Kushal Bhattacharya, aged about 30 years, 1 Resident of Krishnakuthir Apartment, 3rd floor, Uday Shankar Sarani, Ward No. 30, 606 No. 1285 P.S.- Siliguri, P.O.- Siliguri Bazar, District- Darjeeling, within the jurisdiction of d. માલ્યું મુ your police station and I am fully aware of the complete facts & circumstances of the present matter and filing the present criminal complaint in my personal capacity and Ig pls case in lieu of the same, I would like to bring the following to your kind information: That, the instant complaint is against, Sri Tarun Thakur, S/o not known, his wife name not known and his daughters Sweta Thakur and Swagata Thakur, Residents of Second floor (Front side), Krishnakuthir Apartment, Uday Shankar Sarani, Ward No. Soy/Sob/34 30, P.S.- Siliguri, P.O.- Siliguri Bazar, District- Darjeeling. That today i.e., 21.02.2024, at around 06.30- 7.00 p.m, when I was in my flat the aforesaid Sweta Thakur daughter of the aforesaid accused Sri Tarun Thakur called me and asked me endoresev to come to their flat, when I went to their flat and I enquired them about their call to 181 then suddenly all of them without any provocation, the aforesaid Sri Tarun Thakur started to hurl filthy abuses on me saying "maggir bacha suarer bacha toke ar tor Anupam kukur gulo k ekhan theke chure fele debo amra". The wife of the said Sri Tarun Thakur hit me and twisted my hand pushed me. When I tried to stop the quarrel, Sri esh'gon'on Tarun Thakur shouted that I should get rid of my dogs or else he will throw them on the streets. Sri Tarun Thakur and his wife suddenly started to physically hurt me by inflicting me physical harm for no reason. While they continued to physically abuse ne and inflict harm on my body, he persuaded his two daughters Sweta Thakur and Inspector to Wagata Thakur to involve in the fist and blow situation that I was already under. Sri Inspect PoliTarun Thakur and his wife threatened me of dire consequences if I were to be ever be seen in and around the said property with my dogs. That, upon hearing my cries for help the other flat residents gathered there to save me. Due to involvement of our flat residents the abovenamed accused persons could be stopped, however, even towards the end of the dispute, Sri Tarun Thakur kept criminally intimidating me and my dogs to grave consequences. That the said Sri Tarun Thakur has had a history of having an aversion towards my two dogs (BROWN and BUZO) which kept increasing day by day ultimately leading to today's unfortunate incident. No other

flat residents have any problem with my dogs. I still suffer pain due to the said incident, the criminal assault on my body has also led to damage and deterioration my mental health and I am extremely under fear and depression. That said Sri Tarun Thakur has tried to criminally damage my repute saying that he will pee on my door and cause me mental trauma and also threatened me and my dogs of dire consequences in the near future. That, the accused, being well versed of the fact that his actions are unlawful and punishable under prevailing criminal laws, having utter disregard to the law of the land has continued his criminal behavior causing disturbance of peace and order. That, the accused has voluntarily, with an intention to cause wrongful gain has threatened me and dogs of dire consequences, including threat to cause grievous hurt or death to my dogs. That, the above named accused by criminally intimidating me that he shall grievously harm my dogs and implicate me in false cases and has thus committed the offence of "Criminal intimidation". It is pertinent to mention that the accused has caused wrongful loss to me in sheer fulfillment of his ulterior motives and in ultimate violation of the law of the land. That, as you know, I live alone with my son aged 6 years and two dogs in the said building and my husband is located out of station due to his job and I have a good reputation in the area. The accused in fulfillment of his illegal motives has from time to time publicly humiliated and defamed me. It may be noted that such imputations made by him towards me has caused me severe damage to my reputation in the society. The accused publicly to humiliate and insult me and disrespect and insult through his oral and physical imputations. Moreover, I would like to declare that if anything happens to my dogs in the future the abovenamed culprits shall be liable for the same.

Therefore, I request you to enquire into the matter and book the aforesaid culprits namely, Sri Tarun Thakur, S/o not known, his wife (name not known) and his daughters Sweta Thakur and Swagata Thakur under appropriate provisions of law.
