I, ASI Amit Lama of BDR PS, SPC do hereby lodge this complaint against the above noted arrested accused persons that today i.e. on 21.02.2024 at about 19.55 hrs I received a secret source information that 05 persons were coming from Singhijhora T.E. Side by riding with five bicycle for clandestine disposal by fraudulent mean. Accordingly, I informed the fact to you and diarised the fact in General diary vide BDR PS GDE No 1050 dated 21.02.2024 and as per your kind direction myself along with ASI Munna Ahmed, C/1509-Sourav Roy Sarkar, VP/02-Pradip Roy, CV/389-Janak Singha, all of Bagdogra PS left for Singhijhora More to verify the veracity of the information in hand. Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender. At 20.15 hrs we arrived at Singhijhora More and started to Naka Checking at Singhijhora More. At about 20.25 hrs we noticed that said persons were coming from Singhijhora T.E. side but seeing the Naka checking the accused persons tried to fled away from the spot and immediately we rushed to the spot and managed to apprehended 05 (Five) persons with 05 (Five) bicycles. On being asked they disclosed their identity as noted above and failed to produce any valid documents in respect of the above noted bicycles. Being further interrogated they disclosed that they have procured the bicycles clandestinely from various places of Bagdogra PS jurisdiction by illegal way with a view to sell the same in Bihar for their personal gain. On being further interrogation they disclosed more bicycle are kept in an abandoned house at Singhijhora T.E, Line No-5 under Bagdogra PS area. Later on shown and identified by the accused persons I recovered more 11(Eleven) bicycles from an abandoned house situated at Singhijhora T.E, Line No-5. Those are also no any valid papers.

Accordingly, I seized the above noted bicycles from the exclusive possession of the above noted accused persons namely 1) Ronit Lohar (20) s/o Lt Birju Lohar of Kamalpur T.E., PS bagdogra, Dist. Darjeeling, 2) Rabi Oraon (19) s/o Kalu Oraon of Do, 3) Jugal baraik (22) s/o Lt. Rajku Baraik of Do, 4) Karan Lohar (19) s/o Lt. Bikash Lohar of kamal Pur T.E. Baraline, PS bagdogra, Dist. Darjeeling, 5) Biswat Oraon (20) s/o Lt. Munshi Oraon of Kamal Pur T.E. Tankiline, PS Bagdogra, Dist. Darjeeling and subsequently arrested them after observing all formalities and informing the ground of their arrest. The whole process of seizure was made in between 21.30 hrs to 23.20 hrs on 21/02/24

Under the above circumstance, I pray before your good office that a specific case under proper section of law may kindly be started against the arrested accused persons namely 1) Ronit Lohar (20) s/o Lt Birju Lohar of Kamalpur T.E., PS bagdogra, Dist. Darjeeling, 2) Rabi Oraon (19) s/o Kalu Oraon of Do, 3) Jugal baraik (22) s/o Lt. Rajku Baraik of Do, 4) Karan Lohar (19) s/o Lt. Bikash Lohar of kamal Pur T.E. Baraline, PS Bagdogra, Dist. Darjeeling, 5) Biswat Oraon (20) s/o Lt. Munshi Oraon of Kamal Pur T.E. Tankiline, PS bagdogra, Dist. Darjeeling and arrange for its investigation.
