I Sri Sunil Lama, Station Manager, NJP Gate Bazar CCC, WBSEDCL, hereby lodge a Complaint against Biplab Kumar Ghosh, son of Lt. Ajit Kumar Ghosh at Sayanee Apartment, opposite Central Bank Of India, PO-Bhaktinagar PS-NJP, for unauthorizedly supplying power to the disconnected premises of Ranabir Ghosh having consumer id - 401812786 which was disconnected on 16.02.2024 due to non payment as liable u/s 135(i)(e)/150 of IE Act 2003 & Amendment act 2007.

On dated 21.02.2024 at about 14:00 hrs, I along with 1) Sri Pranab Sikdar, SO, S & LP is from Darjeeling Regional Office, WBSEDCL, and other officials of WBSEDCL visited the premises of said above for inspection. During inspection it was found that unauthorized use of electricity consumption iro consumer id - 401929879 with meter no: G01885938 as liable u/s, 135(i)(e)/150 of IE Act 2003 & Amendment act 2007.

As the dishonest use of electricity is detected, the service connection has been disconnected and removal of connecting PVC copper wire. The wire has been seized by me by preparing a formal seizure list duly signed by the present user in the premises.

Biplab Kumar Ghosh, son of Lt. Ajit Kumar Ghosh at Sayanee Apartment, opposite Central Bank Of India, PO-Bhaktinagar PS-NJP has committed an offence u/s 135(i)(e)/150 of IE Act 2003 & Amendment act 2007. You are requested to take cognizance of the same by treating this complaint as an F.I.R.
