In producing herewith three (03) arrested accused persons namely (i) Prosenjit Sarkar (27), S/O- Sudip Sarkar of Dakshin Shantingar, Bowbazaar, PO- Goghomali, PS- Bhaktinagar, Dist.- Jalpaiguri (not verified) (ii) Raj Shekhar Mukherjee @ Ratun (29) S/O Rajesh Mukherjee of Telipara, near Maa Tara Bazaar, PO- Goghomali, PS- Bhaktinagar, Dist.- Jalpaiguri (not verified) and (iii) Suman Basumata @ Beekey (23) S/O Asish Basumata of Pradhan Para Ward No. 42, PO- Salugara, PS- Bhaktinagar, Dist.- Jalpaiguri (not verified) arrested u/s- 41 Cr. P.C along with the following seized articles viz:

- (1) One iron-made sword measuring 34 inches approximately including butt from the possession of Prosenjit Sarkar which was kept on his left hand.
- (2) One iron rod measuring 29 inches approximately from the possession of Raj Shekhar Mukherjee which was kept concealed on his backside.
- (3) One iron-made knife measuring approximately 8 inches including butt seized from the possession of Suman Basumata @ Beekey which was kept concealed o his back.
- I, SI Agen Lepcha, S/O- Dup Tshering Lepcha of Ashighar Out Post, Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above-noted accused persons namely (i) Prosenjit Sarkar (27), S/O- Sudip Sarkar of Dakshin Shantingar, Bowbazaar, PO- Goghomali, PS- Bhaktinagar, Dist.- Jalpaiguri (ii) Raj Shekhar Mukherjee @ Ratun (29) S/O Rajesh Mukherjee of Telipara, near Maa Tara Bazaar, PO- Goghomali, PS-Bhaktinagar, Dist.- Jalpaiguri and (iii) Suman Basumata @ Beekey (23) S/O Asish Basumata of Pradhan Para Ward No. 42, PO- Salugara, PS- Bhaktinagar, Dist.- Jalpaiguri to the effect that today on 23/02/2024 at 00:05 hrs. received a source's information that about 12/14 youths have assembled near Ektiashal Haat under Bhaktinagar PS to commit dacoity in a house at Ektiashal area under Bhaktinagar Police Station. The fact was diarized in GD vide Ashighar O.P. GDE No- 728 dated 23/02/2024. Subsequently, after sharing the information with my OC OP and as per his direction, I along with ASI- Prasenjit Barman, C1031- Sameer Roy, CV-1016 Amrit Roy, and CV-1034 Manojit Barman all of Ashighar OP left for the place to work out the information. At about 00:25 hrs. after reaching near Ektiashal Haat, I met my source, and being pointed by the source we started walking towards Ektiashal Haat Bazaar. After some time, we reached Ektiashal Haat and started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offense and were about to move from the spot.

being the police personnel approaching them they tried to flee away from the spot. However, on hot chase, we managed to apprehend above above-noted three (03) accused persons along with seized articles as mentioned above. However, the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation, the accused persons admitted that they had assembled there with their associates to commit dacoity in a house in the Ektiashal area.

I thereafter, seized the above-noted weapons under the proper seizure list duly signed by the witnesses and acknowledged by the accused persons. Thereafter, I arrested the above-noted accused persons u/s 41 Cr. P.C. under the proper memo of arrests duly signed by the accused persons and also informed them the grounds of arrest. The whole seizure was made between 01:00 hrs. to 01:30 hrs.

Accordingly, I brought the arrested accused persons along with seized articles to Ashighar Out Post for further investigation. During interrogation, it could be revealed by the arrested accused persons that they were gathered there along with their associates to commit dacoity in a house Ektiashal area.

Hence, a specific case may kindly be started under the proper section of the law against the above-noted accused persons namely (i) Prosenjit Sarkar (27), S/O- Sudip Sarkar of Dakshin Shantingar, Bowbazaar, PO- Goghomali, PS- Bhaktinagar, Dist.- Jalpaiguri (not verified) (ii) Raj Shekhar Mukherjee @ Ratun (29) S/O Rajesh Mukherjee of Telipara, near Maa Tara Bazaar, PO- Goghomali, PS- Bhaktinagar, Dist.- Jalpaiguri (not verified) and (iii) Suman Basumata @ Beekey (23) S/O Asish Basumata of Pradhan Para Ward No. 42, PO-Salugara, PS- Bhaktinagar, Dist.- Jalpaiguri (not verified)and others and arrange for its investigation.
