With due respect, I, SI Goutam Mallik of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against accused namely Pinki Barman (Female/32 yrs) W/O Late Milan Barman of Bagha Jatin Colony, near Bhanu Ranjan Ghat, Ward No-02, PS- Pradhan Nagar, Dist.- Darjeeling to the effect that on 23.02.24 at 14.15 hrs I received a specific source information that one lady namely Pinki Barman of Bagha Jatin Colony, near Bhanu Ranjan Ghat is selling illicit liquor at her residence without any valid license. Accordingly, I diarized the fact in general diary vide Pradhan Nagar PS GDE No 1570 dated 23.02.24 and informed the matter to the I/C Pradhan Nagar PS. As per his kind order and direction, I along with SI Bandhan Roy, ASI Biplab Kr Das, C/1411 Ashok Roy, C/1413 Sujit Sarkar, LC/1263 Sujata Thapa all of Pradhan Nagar PS left for Bagha Jatin Colony to verify the veracity of source information. On reaching there and as identified by the source, I along with other officers and force and lady force conducted raid at the house of accused Pinki Barman of Bagha Jatin Colony under PS- Pradhan Nagar, Dist.- Darjeeling. But seeing the police party she managed to fled away from the back side. We tried to apprehend her but in vain. On search16 (Sixteen) bottles of 60 up Himalayan Gold India made liquor containing 600 ml in each bottle i.e. total (16 x 600) = 9.600 ltrs recovered from her residence which she kept in a paper made cartoon. During enquiry it could be learnt that the said lady is running such type of illegal business of selling illicit liquor at her residence since long for her wrongful gain. Accordingly, I seized the same under proper seizure list in presence of witnesses and marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A1. The whole process of seizure and label has been made in between 14.35 hrs to 15.45 hrs at the spot.

I, therefore pray before your good self that a specific case may kindly be initiated against accused Pinki Barman (Female/32 yrs) W/O Late Milan Barman of Bagha Jatin Colony, near Bhanu Ranjan Ghat, Ward No-02, PS- Pradhan Nagar, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
