

In producing herewith one arrested accused person namely Arjun Gurung (59) S/O Lt. Adhir man Gurung of Bandrijote, river side, P.O. Champasari, PS- Pradhan Nagar, Dist.- Darjeeling under arrest along with following articles under proper seizure. The ground of arrest duly been communicated with him.

(i) 12 (Twelve) bottles of 60 up Himalayan Gold India made liquor containing 600 ml in each bottle i.e. total (12 x 600) = 7.2 ltrs which was kept in a nylon bag and marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A1".

I, ASI Biplab Kr. Das of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person named Arjun Gurung (59) S/O Lat. Adhir man Gurung of Bandrijote, river side, P.O. Champasari, PS- Pradhan Nagar, Dist.- Darjeeling to the effect that on 23.02.2024 at 14.25 hrs. I received a source information that one person storing and selling illicit liquor illegally at his residence without any valid license. Accordingly, I share the information with you and noted in GD book vide Pradhan Nagar PS GDE No. 1582 dated 23.02.2024.

As per your kind order and direction, I along with force left from PS to held raid at the house of above noted accused managed to apprehend him. On being asked he disclosed his identity as noted above and on search his residence I recovered above noted articles kept in a nylon bag. On demand he failed to produce any valid license/papers for selling and storing of such illegal liquor in his residence. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license since long for his illegal gain. Accordingly, I seized and label the above mentioned illegal illicit distilled liquor from his procession in between 17.50 hrs to 18.35 hrs and subsequently, arrested the above mentioned detained person namely Arjun Gurung (59) S/O Lat. Adhir man Gurung of Bandrijote, river side, P.O. Champasari, PS- Pradhan Nagar, Dist. - Darjeeling after observing all sorts of formalities at the spot for violating the norms of Bengal Excise Act and inform him about the ground of his arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against accused namely Arjun Gurung (59) S/O Lat. Adhir man Gurung of Bandrijote, river side, P.O. Champasari, PS- Pradhan Nagar, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
