I, Sri Aktar Sardar, S/O Late Abdul Jabbar Sardar resident of Tulat, PO-Bholanathpur, PS-Kumarganj, Dist.-Dakshin Dinajpur, 733141 posted as Station Manager at Fulbarihat C.C.C under P.S NJP, District: Jalpaiguri, empowered by the Electricity Act 2003 (Amendment Act 2007), hereby lodge this complaint against **Phalani Das resident of Jaldampurpara, Sahudangihat** under Bholer Alo Out Post Dist- Jalpaiguri for the violation of U/S 135/1/A of the Electricity Act 2003 as stated below.

On the afternoon of 21.02.2024, I, accompanied by my staff, including Mr. Srikanta Chakraborty, S/O Mr. Nihar Chakraborty, J.E (E) Grade-II, and Mr. Suranjit Sarkar, S/O Late Paran Chandra Sarkar, ACM attached to Fulbarihat C.C.C, WBSEDCL, conducted a raid and inspection of the premises of **Phalani Das at Jaldampurpara, Sahudangihat**.

During the inspection, it was discovered that the said consumer is enjoying electricity by direct hooking from nearby LT line at her disconnected premises being defaulter of electricity bill with unpaid OSD of Rs.8256/-as on 21.02.24. Therefore, Phalani Das is accused of violating U/S 135/1/A of the Electricity Act 2003, in accordance with the Amendment Act 2007. I have prepared an inspection memo from 5.00 to 5.15 pm and disconnected electric connection and she has put her sign at inspection copy and no material has been seized from her premises.

I kindly request that you take the necessary action in this matter.
