I, Sri Subhendu Chowdhury, (Aadhar no: 565548848198) S/O late Shardendu Chowdhury, AE & Station Manager, Shivmandir Customer Care Centre do hereby lodge this complain in favour of Smt Malika Rani Singha W/o Sri Amit Singha Vill- Lachka, PO-New Rangia, P.S. Bagdogra, Dist Darjeeling, has committed an offence by directly hooking from the LTOH line.

The Details are stated below.-

On 22.02.2024 at about 02.20 pm the undersigned along with Ainal Kabir (J.E-II Shivmandir CCC) and technical staff have inspected the consumer premises (having Con id-401364627) during inspection, it found that the above mentioned consumer, whose service line was disconnected due to non payment of outstanding amount was illegally engaged in drawing electricity from LTOH line by way of direct hooking and enjoyed the assesses load of 0.42 KVA. The seizure list and inspection report has been prepared in presence of witness named Sri Pradip Sarkar and Barun Singha and acknowledge to the Sri Jogen Singha, (accused uncle in law) as a token of receipt. The team left the premises at around 02.30 pm on 22.02.2024

The accused person Smt Malika Rani Singha W/o Sri Amit Singha has committed an offence under section 135/1(a) of Electricity Act (Amendment) 2007. Hence, you are requested to take necessary action under the law and treated as F.I.R.
