I, Sri Subhendu Chowdhury, S/O late Shardendu Chowdhury, AE & Station Manager, Shibmandir Customer Care Centre do hereby lodge this complain in favour of Smt Sumitra Roy W/o- Sri Prasenjit Roy Vill - Kawakhali, PO - Sushrutanagar, P.S. Matigara, Dist Darjeeling, has committed an offence by directly hooking from the LTOH line.

The Details are stated below.-

On 22.02.24 at about 5.00 pm the undersigned along with Ainal Kabir (J.E-II Shibmandir CCC) and Sonam Sherpa Sr. O.E and technical staff have inspected the deemed disconnected consumer flat i.r.o Sri Biplab Singha S/o Dharendra Nath Singha, whose service connection was disconnected due to non payment of outstanding amount for prolong period and same connection was under deemed disconnection. On inspection undersigned notice that Smt Sumitra Roy W/o Sri Prasenjit Roy was illegally indulge in providing extension of line to Sri Biplab Singha flat within same building. The service line is being disconnected on the spot and the seizure list and inspection report has been prepared in presence of witness named Sri Alokesh Dutta and Sri Rupan Ghosh and acknowledge to the Sri Rupan Ghosh (representative of accused person) as a token receipt. The team left the premises at around 6.10 pm on 22.02.2024

The accused person Smt Sumitra Roy w/o Sri Prasenjit roy has committed an offence under section 135/1(e) of Electricity Act (Amendment) 2007. Hence, you are requested to take necessary action under the law and treated as F.I.R.
