Sir,

In producing herewith one accused person named Kanai Das @ Deb (24yrs) S/O Manoranjan Das of Dasarat pally Bazar w/n 44 PO Sevoke road PS Bhaktinagar Dist Jalpaiguri under arrest along with following articles under proper seizure.

I, SI Youel lepcha of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Kanai Das @ Deb (24yrs) S/O Manoranjan Das of Dasarat pally Bazar w/n 44 PO Sevoke road PS Bhaktinagar Dist Jalpaiguri to the effect that today on 23.02.2024 at about 13.55 hrs received a source information that one person is randomly selling liquor at Dasarat pally Bazar under Bhaktinagar PS without any valid license.

Accordingly I informed the matter to the I/C PS and as per his kind direction I along with ASI Chandra Prakashj Adhgikary, C/ 912 Nukul Chandra Singha had been to Dasarat pally Bazar under Bhaktinagar PS to verify the veracity of source information. After reaching there and as identified by the source found that one person was selling illicit liquor at Dasarat pally Bazar Subsequently, I along with my force cordoned the area and able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and recovered One multi colour nylon bag containing 13 (thirteen) bottles of Himalayan gold 60 up bottled by Himalayan endeavor PVT LTD West Bengal, each containing 600 ml total 7800 ml (7.8 liters).

Further being searched the above noted seized articles was found at his possession. On demand he failed to produce any valid license/papers for selling of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06 (six) months for his illegal gain. Then I seized the above mentioned illegal illicit liquor under proper seizure list in presence of witnesses and arrested the above mentioned person named Kanai Das @ Deb (24yrs) S/O Manoranjan Das of Dasarat pally Bazar w/n 44 PO Sevoke road PS Bhaktinagar Dist Jalpaiguri after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 15.45hrs to 16.15hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Kanai Das @ Deb (24yrs) S/O Manoranjan Das of Dasarat pally Bazar w/n 44 PO Sevoke road PS Bhaktinagar Dist Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
