Sir,

In producing herewith one arrested accused person namely Binoy Roy @ Karan (49) S/O Lt. Balcharan Roy of Khaikhai Bazaar, Ektiashal, PO- Sevoke Road, PS- Bhaktinagar, Dist.- Jalpaiguri along with the following articles under proper seizure list: -

(i) 20 (Twenty) sealed bottles of 'BAZIGAR 70 UP' India Made Liquor each bottle containing 300 ml, i.e. 300*20=6000 ml and marked as "Exhibit-A" out of which 01 (One) bottle taken as a sample and marked as "Exhibit -A-1".

I, SI Agen Lepcha, S/O Dup Tshering Lepcha of Ashighar OP under Bhaktinagar Police Station Siliguri Police Commissionerate would like to lodge this written complaint against the above-noted arrested accused person namely Binoy Roy @ Karan (49) S/O Lt. Balcharan Roy of Khaikhai Bazaar, Ektiashal, PO- Sevoke Road, PS- Bhaktinagar, Dist.- Jalpaiguri to the effect that today on 23/02/2024 at 16:05 hrs. I received a piece of source information that a person is selling liquor in his roadside Dhaba (without a name) at Khudiram Colony under PS - Bhaktinagar, Dist.- Jalpaiguri without any valid license. Accordingly, the fact is diarized in the General Diary vide Ashighar OP GDE No 748, Dated 23/02/2024, and shared the information with O/C Ashighar OP and as per his kind direction, I along with force had been to Khudiram Colony under PS - Bhaktinagar, Dist.- Jalpaiguri to verify the veracity of the information in hand. On reaching there and as identified by the source we held a raid at the roadside dhaba of accused Binoy Roy @ Karan and managed to apprehend him. On being asked he disclosed his identity as noted above and stated that he is selling illicit liquor at his dhaba without any license for his wrongful gain. On further search, the above-noted seized articles were recovered from his dhaba. On-demand he failed to produce any valid license/papers for selling and storing such articles. On further interrogation, he stated that he had been involved in selling and possessing liquor without any valid license for the last few months for his illegal gain. Then, I seized and labeled the above-mentioned liquor under the proper seizure list and arrested the above-mentioned person named Binoy Roy @ Karan (49) S/O Lt. Balcharan Roy of Khaikhai Bazaar, Ektiasha. PO- Sevoke Road, PS- Bhaktinagar, Dist- Jalpaiguri after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 16:30 hrs. to 16:50 hrs.

Under the above-noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against Binoy Roy @ Karan (49) S/O Lt. Balcharan Roy of Khaikhai Bazaar, Ektiasha, PO- Sevoke Road, PS- Bhaktinagar, Dist- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
