

Subject: FIR.

In producing herewith following three accused namely i) Akash Oraon (20yrs) S/O- Lt Birsha Oraon of Middle Palash, PO- Chmpasari, PS Pradhannagar, Dsit Darjeeling. ii) Sameer Oraon (19yrs) S/O Ashil Oraon of Middle Palash PO Champasari PS Pradhan nagar Dist Darjeeling, iii) Sushil Yadav (26yrs) @ Jatla S/O Ram Ballav Yadav of Dasarath pally ward no 44 PO Sevoke road PS Bhaktinagar Dist Jalpaiguri with following seized articles viz:

 One iron rod measuring 38 inches recovered from the exclusive and conscious possession of Akash Oraon.

ii) One iron made rod measuring 35 inches recovered from the exclusive and Conscious

possession of Sameer Oraon

iii) One iron made weapon called as 'Bhojali' 14 inches recovered from the exclusive and conscious possession of Sushil Yadav (26yrs) @ Jatla

I, SI Rantu Haldar of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted Akash Oraon, Sameer Oraon, Sushil Yadav @ Jatla and 8/9 others to the effect that today on 24/02/2023 at 00:05 hrs received a specific source information that 11/12 miscreants have assembled at Fauji Math behind Sona Petrol Pump under Bhakti Nagar PS, Dist.- Jalpaiguri with deadly weapons and making preparation for committing dacoity at Salugara area. Accordingly, I informed the matter to the I/C, Bhakti Nagar PS and diarised the fact in General diary vide Bhakti Nagar PS GDE No 1266/24 dated 24.02.2024 and as per order I along with ASI Chandra Prakash Adhkari, C/912 Nakul Chandra Singh, C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for Fauji Math behind Sona Petrol Pump under Bhakti Nagar PS, Dist.- Jalpaiguri to work out the information in hand. At about 00.35 hrs we arrived at Fauji Math behind Sona Petrol Pump under Bhakti Nagar PS, Dist.-Jalpaiguri as indicated by the source we noticed that 11/12 persons assembled at Fauji Math behind Sona Petrol Pump and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police repeatedly and started flee away from the spot and after hot chase we managed to apprehended above noted 03 (three) of them with deadly weapons in their possession but 8/9 persons managed to fled away from the spot taking the advantage of darkness and open place.

On interrogation the apprehended accused persons disclosed their name and identity as noted above and also stated that they were making preparation for committing dacoity at Salugara area. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.
