Respected Madam,

With due respect I Smt. Chandana Roy (Karmakar), wife of Late Ajay Karmakar, residing at Adarsha Pally, Ward No. 10 of S.M.C., P.O & P.S. Siliguri, Dist. Darjeeling beg to inform you that my marriage was solemnized with Ajay Karmakar, son of Late Anil Karmakar of K.C. Dey Road, Mohananda Para, P.O & P.S. Siliguri, Dist. Darjeeling, on 10.12.2000 according to hindu rites and customs and after marriage I started to reside with Ajay Karmakar as husband and wife at the above mentioned residence of my husband along with his other family members. After marriage my mother-in-law Smt. Sobha Karmakar and one brother-in-law, Sri Bijay Karmakar started torture upon him on various way. Thereafter two daughters were born out of our wedlock on 01.04.2002 and 13.09.2004 namely Rishika Karmakar and Raima Karmakar. During that period said Sobha Karmakar and Bijay Karmakar tried to oust us from the said house by various means. Said two persons used to provide various drugs to my husband each and every day and ultimately my husband died on 23.12.2019 due to slow poisoning by said Sobha Karmakar and Bijay Karmakar. During his life, time my husband used to run a grill factory in the ground floor of said residence but after death of my husband said Sobha Karmakar and Bijay Karmakar captured said business forcefully and also ousted me along with my two daughters from the said house forcefully. Thereafter on several occasion I went to my above mentioned matrimonial house and requested them to handover the Death Certificate of my husband, lying with them but they always neglected to provide said Death Certificate to me. Thereafter on 09.02.2024 I along with my elder daughter went to my above mentioned matrimonial house at about 06 p.m. and requested them to handover the Death Certificate of my husband but my mother-in-law, Smt. Sobha Karmakar and brother-in-law Sri Bijay Karmakar threatened me not to enter the house and refused to hand over the Death Certificate of my husband but when I raised protest, said Bijay Karmakar assaulted me with fist and blow and also touched different parts of my body with disrespectful manner causing outrage of my modesty. Thereafter he pushed me back and I fell down from the stair case as a result I sustained injury on my left leg.

So I request you to take necessary legal action against said Sobha Karmakar and Bijay Karmakar.


