Respected Sir,

I, **BABLU MUNDA**, SON OF LATE TUNIA MUNDA, am permanent resident of Motajote, Matigara, Post Office and Police Station Matigara, District Darjeeling, PIN.734010. Miss. Arati Munda (alias Riya) is my daughter. She is 22 years old. She is a student and preparing for her competitive examinations. She is taking coaching from Rabindra Bharati, Sevoke Road, Siliguri. She also goes for her tuition/ studies thrice a week at Shivmandir.

One Samrat Roy (Mobile No.62951-61437), Son of Shri Twinkle Roy, resident of Patiramjote, Post Office and Police Station Matigara, District Darjeeling, from last one and half year constantly harassing, intimidating, threatening my daughter and pressurising her to accept his proposal. He and his friends anyhow manage to collect the mobile number of my daughter and often call her at late night. My daughter personally and our family already categorically conveyed our refusal. Said Twinkle Roy and his associates in past tried to pressurised us for his son but we have politely denied. Samrat Roy is still adamant and always stalked, teased and even harassed my daughter severally whenever she goes for her studies and other works. His friend, one Mr. Kanik Sahu, Son of Anil Sahu, resident of Himul Main Gate, Matigara, always followed my daughter, and used to pressurise my daughter to accept the proposal of Samrat Roy.

On 14/02/2024 at about 08:00 A.M., Mr. Prasant Singh, his wife namely, Jyotsna Barman alongwith his brother-in-Law namely, Jayanta Barman and Kanik Sahu, came to my house. Mr. Prasant Singh called my daughter to come and meet them outside. Mr. Prasant Singh and his wife was earlier our tenant. So, my daughter naturally didn't bother to attend them. They came with a plan and on the instigation of Samrat Roy. As my daughter opened gate, all of a sudden they started soughting on her, labelling baseless and castigating remarks on her character, defaming and demeaning her, pushing and thrashing her. We with the help of our neighbours anyhow rescued my daughter. She was mentally shocked and frightened by the ruckus created by them. She felt so ashamed that out of mental agony and frustration locked the door and tried to hang herself. I alongwith my wife break the door and anyhow saved her. We immediately admitted her in Avalon Hospital, Paribahan Nagar, Matigara, at about 10:00 A.M. She was discharged from the Hospital on 15/02/2024.

Aforesaid Twinkle Roy is a political leader and influential person. Samrat Roy is also a very desperate person. He had earlier tried to forcefully abduct my daughter on two occasions. We have lodged police complaint against him, but in vein. My daughter and my family were completely frightened and engulfed by helplessness, insult, agony and frustration. I able to gather my courage anyhow and lodging/ registering my complaint.

I, therefore, request you to take immediate stern action against these criminals and hooligans and their associates and save the life and prestige of my daughter.

I shall be grateful to you for this kind act.
