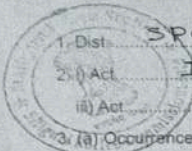

With due respect I Smt. Kakoli Bhowmick, Wife of Sri Mintu Bhowmick, resident of Alphansa Road, North Bengla Medical College, P.O.: Sushruta Nagar, P.S.: Matigara, Dist.: Darjeeling, beg to inform that my only son namely Ankush Bhowmick, who was studying B.B.A, ATA from Insperia, he had committed suicide by hanging himself from ceiling fan hanging from the roof of his bed room which is situated at the first floor of our resident, with a Black and white muffler on 07/02/2024 around 3.30 a.m..

Before three months my son met with one Miss Sneha Sarkar, Daughter of Sri Bubai Sarkar, and one Anush Dutta, Son of Sri Dipak Dutta, both resident of Jharua More, Shibmandir, P.O.: Kadamtala, P.S: Matigara, Dist.: Darjeeling, within very few days they met, I was told by my son that said Sneha Proposed him for a romantic relation and subsequently they started dating each other frequently, the girl use to visit our palace also, hence me and husband had a preliminary talk regarding their marriage in the future, my husband previously new that family.

Being a mother I could feel that the way within a very short span of time that girl kind of hypnotize my son, she might be offering to much sexuality to my son, and I was having a bad vibe and intuition regarding their relationship.

My intuition got right and before a month ago I saw my son to be utterly depressed and roaming around anxiously, on query he told me that the girl had dumped him and refused to keep any kind of touch with him without giving any reason, such sudden breakup after having a long physical relation was unbearable to my son, he was going though tremendous mental pain and agony.

Many times my son requested the girl to sort the relationship between them, but initially she denied, subsequently I was told by my son that the girl was threatening him to published their intimate video.

Just to make my son jealous and suffer more, that girl got involve into love relation with their another friend Ahush Dutta, They always tried to flaunt and saw of their relation to my son and I could see my son to go worre from bed mentally every day, even at times both of Sneha and Ankush mocked my son saying he should die if he was unable to handle one breakup, such kind of commorced and sided the abatement to commit suicide by my son.

On 07/02/2024 my son was heard talking to someone and wiping over phone around 2.15 a.m. just before he committed suicide, his uncle heard that and asked him to sleep.

I am very much sure that the last call was with that girl Shena which abetted my son to commit suicide.

After the death of my son many necked and vulgar videos of that girl were found in the mobile phone of my son which were sent by her.

In view of above facts you are hereby requested to take necessary legal action to do the needful.
