

In producing herewith three (03) arrested accused persons namely (1) Md. Javed @ Biki (23) S/O Md. Jafar of Gwalapatty, Koila Depot. PO. & P.S. Siliguri, Dist. Darjeeling. (2)- Chandan Mohan Choudhary @ Sajan (23) S/O Sikendar Choudhary of Devidanga, Middle Plus More, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling and (3)- Kunal Singha @ Kancha (28) S/O Late Ajit Singha of Kalaramjote, Ghoshpara, P.O. Rangapani, P.S. Phensidewa, Dist. Darjeeling U/S 41 Cr.P.C along with following seized articles under proper seizure list viz.

- 1- One iron made Knife measuring eleven inches approximately including wooden butt from the possession of Kunal Singha @ Kancha.
- 2- One torch light and one Screw driver from the possession of Chandan Mohan Choudhary @ Sajan.
- 3- One iron rod measuring eighteen inches approximately from the possession of Md. Javed @ Biki.

I, ASI Pema Dorjee Sherpa of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (1) Md. Javed @ Biki (23) S/O Md. Jafar of Gwalapatty, Koila Depot. PO. & P.S. Siliguri, Dist. Darjeeling. (2)- Chandan Mohan Choudhary @ Sajan (23) S/O Sikendar Choudhary of Devidanga, Middle Plus More, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling and (3)- Kunal Singha @ Kancha (28) S/O Late Ajit Singha of Kalaramjote, Ghoshpara, P.O. Rangapani, P.S. Phensidewa, Dist. Darjeeling to the effect that on 25.02.2024 at 22:35 hrs. I along with the force left the P.S. for night patrolling duty and during my night patrolling duty on 26.02.024 at around 01:35 hrs. received a sources information that 10/12 youths have assembled under Tokkar bridge, P.S. Matigara with deadly weapons and making preparation for committing datoity in and around the area. Accordingly, I shared the information with I/C Matigara P.S. SPC and as per his kind direction I along with my force proceeded towards Tokkar bridge under pass by keeping our vehicle on safe distance and being indicated by the source from a considerable distance that a group of 10/12 persons were assembled at Tokkar bridge under pass and were whispering in very low voice. Accordingly, we cordoned the place properly and approach towards them. But seeing the presence of police party, they scattered in different direction and started fleeing away but we managed to apprehend three persons along with the above noted articles from their possession as mentioned above, whereas the rest of the accused persons managed to flee away from the spot.

On interrogation the apprehended accused person disclosed their identity as above and admitted that they had assembled there to commit datoity in that area.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the witnesses and acknowledged by the accused person. The whole seizure was made in between 01.55hrs. to 02:40 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons after informing the ground of their arrest.

I accordingly brought the arrested accused persons along with seized article at Matigara Police Station for further enquiry. During the course of interrogation it could be revealed from the arrested accused persons that some others were also with them, but they able to flee away from the spot during the raid.
