Respectfully, I beg to submit that, D. P. Roy former
shown, an Inspector of Police, now posted at Kalimn
long district, as Senior Assistant, Home Guard,
Kalimpong, would used to stay at a common
shared flat at 2nd floor, first Apartment,
Anutan Mukherjee Road, Ubbhaskhally, P.S -
Siliguri, Dist. Darjeeling, where I used to stay
alone, as my wife Kamabi Roy, has deserted
me in between 02/05/2023 and 06/05/2023,
when I was out of my said flat due to
law and order duty at Malda. She has left
the said common shared flat, on those days to
make a point to prove that she lives separately
to obtain a decree of divorce, filed by her
in June, 2021 though after marking the divorce
case, she stayed together with me in the same
flat under the same common roof for about
two years. After she left the flat in my
absence, taking all her belongings and each and
everything that belongs to her and since after
that desertion by her, I used to stay in the
said common shared flat, alone for the
purpose of my job at Siliguri Police Commission
erate.

Recently, I have been transferred to Ralimpong District as Senior Assistant Home Guard, Ralimpong. On 13/02/2024 I left my last flat at 105th Ralimpong district taking only bedding and uniform leaving behind cash and everything there, after closing the door and collapsible gate and putting locks tightly. I have left at the time of leaving the aforementioned common stated that, Cash, Gold, Jewellery and other valuable documents. Suddenly, on 23/02/2024 at around 21:15 hrs. I came to the said flat in a single cloth to take my some of wearing apparels and other daily needed articles and some of my valuable documents and find there that the locks I had put there had been broken and some new locks were put into the entrances. Later I called to Subguro's P.S. to provide some assistance to me to take my needed articles. While the Subguro's P.S. officer on enquiry, during conversations, I came to know that the following persons mounting conspiracy took away my Cash, Gold and valuable documents from inside the said flat, by breaking open the locks of the door and have kept those and their possession, while conversation with the enquiring officer of Subguro's P.S. on 23/02/2024 at about 22:20 hrs. one of the accused Renuki Roy, who is by profession a Police Inspector, now posted at Cooperation Directorate, North Eastern Zone, N.B.S.A.R.D.B. Building, Inyat Rose Road, Itanagar, P.S. Subguro's

At all these activities with assistance and direct provocation from the following accused persons, as she wished not to allow me to enter into the said common household flat with criminal intention to misappropriate all my valuables like cash, Gold, Jewelry and other documents. She also stated that some of the articles she had already lifted. I got no assistance from Sargur's P.S. Police to enter the said flat and had to stay on streets for whole night. Again on 24.02.2024 at about 1845 hrs. when I reached near the said flat to see the condition, I found accused Ranabhi Roy already stole some my valuables and putting into two bags she trying to leave the place. All on a sudden again today at that time Sargur's P.S. Police came into spot and made enquiry, in presence of other inmates of the building. She whimsically refers to the enquiry officer that she will not allow me to enter the flat and stated "Ranabhi Roy, under an order of the said Police officer of Sargur's P.S. to show any order of the Court to put new locks, by breaking the earlier ones and to refrain me to enter the said flat, she could not produce any such order of the said Court. Meanwhile the other accused persons provoked her over phone, for what to do or what not to do. Later, anyhow I got the information the said accused Ranabhi Roy with help and assistance of the other accused noted

below already & he gave me HP 14 10th Gen Intel
Core i5 Processor 14" FHD Laptop (14s Cr. 2000TX Model)
Silver colour, with laptop with accessories and laptop
bag, Cash sum amount ₹ 45000, Gold Jewellery &
other valuable documents.
