Sir,

In producing herewith following seized articles under proper seizure list viz. (i) Five (05) bottles of Himalayan Gold 60° UP Indian Made Liquor, each containing 600 ml @ Rs. 155/- and (ii) Twenty (20) bottles of OYE OYE 70° UP C.S., each containing 300 ml @ Rs. 28/- (total value Rs. 1335/-), I, SI Debabrata Kundu of Bagdogra PS, Siliguri Police Commissionerate, Dist- Darjeeling, do hereby lodge this written complaint against one Jitendra Sahani (M/47 years), S/O- Late Rajdeb Sahani, r/o- Gowala Busty, Dumriguri, Dakshin Bagdogra, PS- Bagdogra, Dist- Darjeeling, PIN- 734014 to the effect that on 23/02/2024 in course of performing special raid duty vide Bagdogra PS GDE No. 1135 dated 23/02/2024 at 20:05 hrs I received secret source information that a huge quantity of liquor is stored at the shop cum house of one Jitendra Sahani at Gowala Busty, Dumriguri, Dakshin Bagdogra and the same has been selling illegally. Accordingly, I informed the matter to O/C Bagdogra PS and I along with force left for Gowala Busty, Dumriguri, Dakshin Bagdogra to hold raid. At around 20:20 hrs we reached at the house cum shop of one Jitendra Sahani and being indicated by source we held a raid to verify the veracity of information. Seeing the police personnel the owner along with some customers managed to flee away from the spot. On enquiry it could be learnt that one Jitendra Sahani (M/47 years), S/O- Late Rajdeb Sahani, r/o- Gowala Busty, Dumriguri, Dakshin Bagdogra, PS- Bagdogra, Dist- Darjeeling, PIN- 734014 is the owner of said shop. Then we held raid and after holding raid, we managed to recover the above noted liquor from the shop cum house of said Jitendra Sahani. On demand, none came forward to produce any valid document/license for possessing, stocking and selling those liquor and country spirit. It could also be learnt that said accused Jitendra Sahani has been possessing, stocking and selling liquor & country spirit from his shop cum house for a long time for his wrongful gain. Accordingly, I seized those liquor under proper seizure list. The process of search and seizure was made in between 20:20 hrs and 20:45 hrs.

Therefore, I request that a specific case under proper section of law may kindly be started against the involved absconding accused person Jitendra Sahani (M/47 years), S/O- Late Rajdeb Sahani, r/o- Gowala Busty, Dumriguri, Dakshin Bagdogra, PS- Bagdogra, Dist- Darjeeling, PIN- 734014 and arrange for its investigation.
