Accordingly I inform the matter to the superiors. As per direction of superiors I, along with ASI Arghya Das, L/C 1270 Deeptina Gazmer , CV/019 Debendra Nath Roy, CV 539 Koushik Mondal all of EB SPC along with investigation kit left for NJP PS vide EB SPC M.C.C No 10/24 Dt.23.02 2024. The matters informed to NJP PS vide GDE No. 1200/24 Dt.23.02.2024 and accompanied with mobile officer SI Chabilal Sinha , C/679 Masud Alam of NJP PS had been to "SARKAR VARIETY STORE" located at Super Market Fulbari under NJP PS to work out the information and brief them about the information in hand and requested them to accompany with us during search and seizure, At about 12:45 hrs we reached at "SARKAR VARIETY STORE" located at Super Market Fulbari under NJP PS, I contacted with source and being shown and identified by the source I along with force conducted raid in the shop of Biswanath Sarkar. And found that the above noted accused person is busy to refilling from the big size gas cylinder to small size gas cylinder. On seeing the police party the above noted accused person tried to flew away from the spot. However the police party managed to apprehended him. On searching, the above noted seized article has been recovered from his shop. On being asked the above noted accused person failed to produce any valid documents in support of above noted seized

It is crystal clear that the arrested accused person namely Biswanath Sarkar S/O Sri Bancharam Sarkar ,40Yrs (Approx) of Purba Dhantala, Fulbari, PS- NJP, Dist- Jalpaiguri is storing, refilling and selling the Domestic cylinders in his shop for his wrongful gain. As per local enquiry it came to light that he negligent conduct with respect to fire or combustible matter, any act so rashly or negligently as to endanger human life or to be likely to cause hurt or injury to person that bazaar area and no valid License/Permit of dealing/distribution/refilling LPG. Thus the above noted accused person violated the provision West Bengal Cooking Gas (License and Control)

Accordingly I seized the above noted seized article as per seizure memo in presence of local witnesses namely 1)Ananta Sarkar of S/O Lt. Suresh Ch. Sarkar of Deshbandhu Para, PS Falakata ,Dist- Alipurduar, at present Fulbari Super Market , PS- NJP , Dist- Jalpaiguri 2) Akash Mallick S/O Babul Mallick of Patiramjote, PS-Matigar, Dist- Darjeeling, 3) CV Kousik Mondal of EB SPC. The seizure was made in between 13:45 hrs. to 15:15 hrs. Then after I arrested the above noted accused person after issuing Memo of Arrest mentioning him
