Sir,

In producing herewith one (01) arrested accused person namely Lakhindar Sahani (37) S/o Kanta Sahani of Ramnagar Majdurbusty PS New Jalpaiguri Dist. Jalpaiguri along with following seized articles viz,

1. Twelve (12) sealed Bottles of Prakash 60up India Made Liquor, each bottle 600 ml, Marked as exhibit-A in which 01 bottle taken as sample for examination exhibit-A1 .
2. Six (06) sealed Bottles of Galaxy BOSS 60up India made Liquor , each bottle 600 ml Marked as exhibit -B in which 01 bottle taken as sample for examination exhibit-B1

I SI Binup Mahato submitted a written complaint against the above noted accused person to the effect that today on 26.02.24 at 21-30 hrs received source information that one person was selling Id Liquor illegally from his house at Ramnagar Majdurbusty to its customers without any valid license. Accordingly, I inform the matter to duty officer and also inform to O.C. PS and as per his direction, myself along with ASI Dhruva Mishra, ASI Khagen Barman, C/1462 Sajjan Tamang, CV-297 Putul Roy, CV- 306 Biswajit Roy , CV-824 Niru Yadav all of NJP PS, SPC left for Ramnagar Majdurbusty, PS- NJP, Dist- Jalpaiguri to work out the information in hand which noted in GD vide NJP PS GDE No. 1384 Dated- 26.02.24. At 21.55 hrs we arrived at Ramnagar Majdurbusty and on pointed out by the source I with the help of my accompanied officers and force held raid in the house of above noted accused person and apprehended the above noted person who was selling ID liquor from his house . On seen the police party some customers managed to flee away from there. On being asked the apprehended person disclosed his name and address mentioned above. Thereafter in presence of witnesses I recovered 1. Twelve (12) sealed Bottles of Prakash 60up India Made Liquor, each bottle 600 ml 2. Six (06) sealed Bottles of Galaxy BOSS 60up India made Liquor , each bottle 600 ml from the possession of the apprehended person from his house and seized the same as per proper seizure List and labelled duly signed by him and also witnesses. On being asked he failed to produce any document or license for selling the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 41 Cr.P.C. as It's a violation under Bengal Excise Act. This seizure & arrest was made in between 22-05 hrs and 22-35 hrs (seizure Total approx 10.8 Ltrs).

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Lakhindar Sahani (37) S/o Kanta Sahani of Ramnagar Majdurbusty PS New Jalpaiguri Dist. Jalpaiguri and arrange for its investigation.
