Sub: Report of Missing Toto and Suspected Involvement of Driver

Respected Sir,

I am writing to formally report the disappearance of my Toto, which I strongly suspect is connected to the actions of my driver, Tapan Dey. The incident occurred on January 18, 2024, and I have compelling reasons to believe that Tapan Dey is involved in this case.

Tapan Dey has been employed as my Toto driver for the past 8 months, until this unfortunate incident. On the aforementioned date, Tapan Dey departed from my garage at approximately 5:40 PM, taking the Toto along with the charger of the electric rickshaw without my authorization. Furthermore, upon investigation, I discovered that the keys to the garage were also missing, indicating a deliberate act of planned theft.

Despite my immediate efforts to locate both Tapan Dey and the missing Toto, including reporting the incident to the Pradhan Nagar Police Station on 20.01.24 with GD ref. no 1083 in your Police Station and conducting searches in the vicinity near Kanchanjunga Athletic Club as suggested by Tapan Dey, no substantial leads or conclusions have been reached and was rather misleading.

Given these circumstances, I am compelled to file a case against Tapan Dey for his suspected involvement in the theft of my Toto. I have enclosed all relevant documentation, including proof of ownership and registration details of the Toto, for your reference and investigation.

I kindly request your prompt intervention and thorough investigation into this matter to apprehend Tapan Dey and recover the stolen Toto. I am fully committed to cooperating with the authorities and providing any necessary assistance to facilitate the investigation process.

I trust that you will take appropriate action in this case, and I look forward to receiving updates on the progress of the investigation.
