Dear Sir,

D/O. Pintu Chakraborty.
I Mistu Chakraborty, Advocate of Siliguri Court doing practice as an Civil & Criminal Advocate, at Siliguri Jurisdiction do hereby states as follows:- *at present I am residing at Sainikpuri, P.O. New Chumta P.S. - Matigara, Dt - Darjeeling*

1. That I have a Stationery & Cosmetic shop situated at Khaprail Hariya more in Sukul Saha Building, P.O. New Chumta, P.S. Matigara, District-Darjeeling.
2. That adjacent to the said shop I have a chamber also at the said building.
3. That I have appointed one staff namely Rina Mahato presently residing in rent at Pathak House opposite Puja Shop, Sainikpuri, Khaprail, P.O. New Chumta, P.S. Matigara for running the said shop.
4. That I have purchased various items for my said shop in the month of August and subsequently I have also invested a sum of Rs. 17,000/- in the month of October to November and I have invested a sum of Rs. 30,000/- in the month of December.
5. That at the end of January when I asked to my said employee for Profit & Loss of my said shop then F.I.R named person took sometime to produce the account details.
6. That after elapsed of 15 days again I requested her to provide me the details of stocks of my shop along with cash balance.
7. That on 21st February I noticed that the various items which I have purchased for my said shop, but the items are not seen on the said shop then I told her either it is sold or elsewhere.
8. That on the sametime said F.I.R name Accused person confessed her guilt and replied me that she had sold the items and induced the money along with profit.
9. That thereafter I interrogated the accused person with the help of other shop owners and at the time of interrogation the accused person confessed that she had stolen some cosmetic items and gift items and also misappropriate the sell amount of the said shop, and the accused person also make a self declaration and duly signed and accept her fraudulent activities.
10. That due to taking advantage I used to go to court at the day time and taking simplicity of my profession she misappropriated the money a sum of Rs. 47,000/- and more except the profit amount with the help of her one associate namely Joyanto who is also reside with her.

Under the above circumstances it is therefore requested before you please take necessary legal step against the accused person and her associate as per the course of law.
