Most Humbly, I Smt. Komal Paswan, wife of Sri Ganesh Paswan, Resident of Khalpara, Vivekanand Road, by lane Lear Shiv mandir ward no-8 of S.M.C, P.O & P.S.-Siliguri dist-darjeeling do here by lodge this F.I.R before you to the effect stating that on dated-22/02/2024 about 9 pm I was alone at my own resident and when my brother-in law namely kartick paswan s/o Sri nathu paswan reached at home then I ask him for my dues money which was I given him because in few days I have to paid in my child school for the purpose of admission but he denayed and started abusing me in filthy languages in that time he was in drunken position, after hearing his loudly voice my father-in law Nathu paswan along with his wife and my another brother-in law pappu paswan came out their room and said me that if I again want money from kartick paswan then they will through out me and my children from the house and threatened me badly within this time Kartick paswan hit on my head by a iron rod and started beaten me badly as well as my father-in law, mother-in law and pappu paswan kick me by their leg on my stomach and on my chest also. Kartick paswan and other in-laws beat me badly. In this incident my head get swelling blood and I got cut on my left hand finger, also internal pain in my private part and stomach they badly physical assaulted me, they try to torte my cloth also my both children save me and take me to the district hospital. Sir I was married with Ganesh paswan in the year 2003 by the hindu rites at sevoke kali mandir by the consent of both family but after some year my in laws torturing me everytime they want I leave their house with my children and I inform you that my husband not given any type of expences to me and my children we live seprately I doing job in a house for living my life doing job of a maid but they try to through out me from this house now they do not allowing to enter in home. Now I am stay at road with my children..

Hence I pray to you that necessary take legal action all the above named accused persons.
