Rajganj, under Binnaguri gram panchayat area, Police Station-Bhaktinagar, A.D.S.R. Office-Bhaktinagar, Pincode-734006, District-Jalpaiguri, ROR as BASTU & Proposed of used land As BASTU, in the State of West Bengal, by virtue a registered sale deed vide dated 07.06.06.1965, being no. I - 5449/1965, it was executed by Dulu singh roy, resident of Jalpaiguri. After the demise of my father my mother Smt. Bina Aditya and my brother Sri. Ranabir Aditya along with me, is the absolute owner of the above mentioned land.

That we were not able to take proper care of the above mentioned land due to some personal problems, so we had appointed Sri. I - 5449/1965 into his custody and promised to return the Original sale deed after registration but despite of having several reminders from our side he still haven't returned the same to us. Each and every time he is making new excuses and avoiding us and this kind behaviour is triggering concern that he might have misused the deed to gain some illegal benefits out of it.

It's my humble request to you to take necessary and quick action against him so that he can be prevented from misusing the original sale deed and I should get the original deed back which is a very important legal document for us
